### **ECONOMIC IMPACT PAYMENTS** from the federal government may require **additional steps** from taxpayers.

If you didn't file a tax return in 2018 or 2019,  
you may need to provide details **HERE**:

**NOTE: May 5th is an important deadline for SSI beneficiaries who have **DEPENDENTS**.**

*These households need to register their dependents through the [IRS link](http://www.irs.gov/coronavirus/non-filers-enter-payment-info-here) by **MAY 5th** to receive an additional \$500 per dependent.*

**>> If you get VA or SSI benefits and did not file tax returns for 2018 and 2019 and have qualifying children, you must enter information by TUESDAY, MAY 5 to get \$500 per child by going here: <http://irs.gov/nonfilereip>. Otherwise you will have to wait until you file a tax return next year to receive the payment for your qualifying children**

Economic Impact Payments are an important part of ensuring families can pay rent and other bills.

Economic Impact Payments from the federal government may require additional steps from taxpayers. ### Important May 5th deadline for SSI and VA beneficiaries

Note: May 5th is an important deadline for SSI and VA beneficiaries who have dependents. These households need to register their dependents through the [IRS link](http://www.irs.gov/coronavirus/non-filers-enter-payment-info-here) by May 5th to receive an additional \$500 per dependent.

People who get VA or SSA benefits and did not file tax returns for 2018 and 2019 and have qualifying children must enter information by Tuesday, May 5th to get \$500 per child. You can register here, otherwise you will have to wait until you file a tax return next year to receive the payment for your qualifying children.
