





ESG Updates



The NC BoS CoC successfully applied for ESG-CV-1 funding!

NC DHHS released a list of awarded NC BoS CoC ESG-CV-1 projects:

- Crisis Response awards totaled: \$2,268,316
 - 24 street outreach and emergency shelters awarded funding
- Back@Home awards totaled: \$5,807,323
 - 16 agencies awarded rapid rehousing and homelessness prevention funding
 - Currently, three counties in Region 10 have no B@H funding. NC DHHS is negotiating with an awarded program to take Duplin, Wayne, and Sampson Counties

The NC ESG Office released the 2021 ESG RFA on August 17th.

ESG funding for CY2021

Traditionally, the annual ESG process has been facilitated at the regional-level.

After feedback from the Steering Committee and Regional and ESG Leads, staff propose following a similar process to the ESG-CV-1 funding process.

- An ESG Funding Process change would require approval by the Steering Committee because it is defined in the NC BoS CoC Governance Charter.
- Staff propose not changing the Governance Charter until after the process.




The review/selection process will add an extra layer of oversight.






Regional Committees will play a similar role, providing priorities and recommendations.





Staff have incorporated an appeals process.





Proposed funding process incorporates other aspects of the ESG-CV-1 process.

- 60/40 split
 - Minimum 60% for Housing Stabilization
 - Maximum 40% for Emergency Response
- Target 'Fair Share' per region with flexibility and approval of regions
- One Regional Application and Budget completed by NCCEH staff
- Project Applicants submit directly to NC DHHS after approval
- Regional Leads relay relevant competition information to committee
 members and interested agencies



2020 Racial Equity Assessment



HUD requires CoCs to conduct a Racial Equity Assessment annually to understand disparities.

Since the FY18 CoC competition, HUD has charged CoCs to assess racial disparities using Point-In-Time and HMIS data.


• Assists CoCs to develop strategies to achieve racial equity

Through a collaboration of NCCEH staff and the RE Subcommittee, we will present the 2020 RE Assessment.

- Data Center and CoC staff pulled data from the PIT count and HMIS and presented this data to a RE Assessment Workgroup on July 16th.
- Staff drafted the initial RE Assessment document and worked with the workgroup to refine the messaging and goals.
- The RE Subcommittee reviewed the draft document on August 19th, giving feedback and asking questions. The subcommittee approved the RE Assessment and recommends the document to the Steering Committee for approval today.



Social Ecological Model






HUD's Continuum of Care Assessment Tool Who does the CoC serve in comparison to people in NC and people in poverty?

• People who are Black or African American are *overrepresented* among those experiencing homelessness




PIT Comparison of Race

• People who are Hispanic or Latino are *underrepresented* among those experiencing homelessness




PIT Comparison of Ethnicity



Additional Populations



PIT Comparison of Ethnicity in Families


National Alliance to End Homelessness **Race Equity Tool** Who accesses permanent housing in the CoC?

People Experiencing (Sheltered) Homelessness






People Experiencing (Sheltered) Homelessness




White Black Native American All Other Races




PH EXIts Bos Census

Collaborative and inclusive dialogue and action are essential elements of our RE work!

Collaborative and inclusive dialogue and action

- Recruit new members to improve representation
- Use the expertise of the RE Subcommittee to guide discussions
- Adopt a decision-making tool to guide governance, policy and decisions
- Host dialogue calls on RE to engage CoC stakeholders
- Recruit and foster partnerships led by POC to increase opportunities for investment in projects



More in-depth evaluation requires robust data collection and innovative assessment.

Data collection and assessment

- Encourage and support better data entry allowing more detailed evaluation
- Include age, ethnicity, and gender in analysis to understand their intersection
- Conduct qualitative research
- Develop additional questions using existing data sets such as BNLs, VSP programs, and CE
- Study agency staff demographics versus people they serve
- Use Stella platform to understand how POC access the system and their outcomes.



Training and support are necessary components of setting a baseline understanding of RE so the CoC can make substantive change.

Training and support

- Include RE and the CoC Anti-Discrimination Policy as a topic in presentations throughout the CoC
- Incorporate RE questions and checks in funding process scorecards and program monitoring oversight
- Hire professional facilitators experienced in RE to provide training and coaching to set a baseline understanding of racial disparities and equity in the CoC
- Share resources on RE with CoC stakeholders and offer time to them for dialogue and questions



RE Subcommittee recommends the RE Assessment to the Steering Committee for approval.


While a formal approval is not required, the RE Subcommittee would like the Steering Committee to approve the RE Assessment to acknowledge the disparities present in the CoC and commit to the goals and action steps.

Eviction Diversion Strategies



Statewide Diversion Programs

Each community is different based on needs and resources, but generally there are 3 main diversion strategies

- Connecting Tenants to Resources
- Connecting Tenants with Attorneys
- Mediation Programs



Legal Services Providers Across the State

- Legal Aid of NC (LANC)
- Pisgah Legal Services
- Charlotte Center for Legal Advocacy



City of Asheville/Buncombe County

- Pisgah Legal Services + Some CDBG funding from City of Asheville
- PLS reviews eviction docket and calls all defendants
- Partnering with local mediation provider for upcoming filings



Partnering with local Community Action Agency

- Connecting clients with CSBG resources in 5 counties
- CSBG dollars more flexible than CDBG or ESG



Partnering with Mediation Providers

- Connect landlords and tenants with a third party who can facilitate payment plans and other resolutions to eviction matters
- Pair mediators, tenants, and rental assistance to avoid eviction
- Communities across the state are connecting with mediators in different ways
- Timing: Prior to an eviction filing, after eviction filing, during appeal stage
- Referrals: NC DHHS, Clerk of Court, Direct Client Referral, etc



Legal Aid Statewide Eviction Diversion Project

- Legal Aid trained 200 volunteer attorneys to advise tenants facing eviction and negotiate settlements with landlords.
- Legal Aid provides expert support/mentorship to those volunteers.
- Program is statewide.
- If volunteer cannot resolve case, tenant will either receive advice or representation from a local Legal Aid office.
- Tenants call 1-866-219-5262.

Mecklenburg County Eviction Diversion Project

- Partnership with Mecklenburg Courts, Crisis Assistance Ministry, Charlotte Mecklenburg Housing Partnership
- Tenants can call 1-877-236-2926 (preferred, number on the flyer) Or 1-866-219-5262 (general Legal Aid number)
- Information sheets sent with every summons and complaint
 - Defenses
 - How to present a defense
 - LANC's phone number
 - LANC helps w/ referrals for financial assistance to Crisis & CMHP



Mecklenburg County Eviction Diversion Project

- Courthouse clinic
 - Magistrate announces LANC's presence and gives tenants an opportunity to talk to us before calling their cases
 - LANC screens tenants for eligibility and if eligible advises or represents in court depending on whether tenant has a defense.

Mecklenburg – Two Mediation/Dispute Resolution

- Dispute Settlement Forum
 - Offers tenants an opportunity to settle rent disputes with the property owners in an effort to avoid an eviction. Tenants meet with representatives of the Landlord, consult tenant's attorneys, apply for financial assistance through community resources, and talk with Dispute Resolution Professionals to reach a settlement
- Dispute Resolution Hotline (September)
 - Pairs mediators and rental assistance for tenants at eviction appeal stage



Durham Eviction Diversion Project

- Partnership Between Duke Civil Justice Clinic and Legal Aid of North Carolina, in cooperation with the Durham County Department of Social Services & Courts
- Primary Goal is to avoid eviction judgments and in the long run to decrease number of eviction filings
- Tenants can call DSS at (919) 860-8000 (preferred, number on the flyer) or 1-866-219-5262 (general Legal Aid number)



Durham Eviction Diversion Project

- Flyer is served to the tenant with each eviction summons
- Tenants directed to contact DSS for participation in the program or to come to our clinic
- DSS social workers refer applicants to Legal Aid when conducting emergency assistance screening; housing questionnaire filled out.
- Legal Aid helps identify legal defenses and negotiate settlements with landlords
- Conduct weekly walk-in housing clinic at Durham courthouse.


