### **CoC Competition Update**

### Awaiting information from HUD regarding plans for the FY20 CoC Competition.

HUD staff on a recent HUD COVID-19 Office Hours call reported that the SNAPS office is advocating for a non-competitive CoC Program funding process this year. This requires Congressional approval. CoC staff will continue to update the Steering Committee and other NC BoS CoC stakeholders as more information becomes available.

In preparation if the FY20 competition happens, agencies interested in applying for new projects should submit an Intent to Apply form. An Intent to Apply form is mandatory to apply for new funding in the FY20 competition. Staff will acknowledge receipt of submission and schedule a follow-up call once more information is available about this year's competition.

### NC Balance of State CoC Funding and Performance Subcommittee October 15, 2020 Minutes




- Brian welcomed members and introduced the agenda for today's meeting.
- Andrea gave an update on the progress for a dashboard to use for monthly Steering Committee meetings.
  - The NCCEH Data Center has requested an upgrade to system reporting from WellSky to allow a custom field for NC County of Service.
  - Staff have worked with ICA, the consultant helping design the dashboard, and they are ready to go once the custom field has been added to the system.
  - Staff are hopeful to have a dashboard by January 2021.
- Brian provided context for the discussion at the meeting.
  - At the July 2020 meeting, the committee discussed the need to increase HMIS bed coverage. Increased bed coverage helps in multiple ways:
    - Systemically
      - Scored in the annual CoC program competition and is an area that the NC BoS CoC needs improvement
      - Provides more accurate and comprehensive data to understand the scope of homelessness in the CoC
      - Allows the CoC to look more closely at trends over time
    - Practical
      - Enhances coordination of services and increases opportunities for people experiencing homelessness to find permanent housing
      - Provides increased coordination at BNL meetings and more comprehensive reports
- Andrea presented the current status of bed coverage by number of beds and percentage of bed coverage by program type in the NC BoS CoC.
- HMIS coverage by Project Type:

- These charts highlight the number of beds and percentage of beds in programs participating in HMIS, in programs not participating in HMIS, and in victim service programs prohibited from participating in HMIS.
- In general, the NC BoS CoC has excellent bed coverage for RRH and PSH programs. This is likely
  due to these services almost exclusively being funded through the ESG and
  CoC programs. The PSH beds not in HMIS are overwhelmingly HUD-VASH



beds. VAMCs are not required to participate in HMIS and have been hesitant to participate. Recently, HUD announced an initiative with VAMCs to import data from the VA HOMES software into HMIS. The NCCEH Data Center is working with local VAMCs and our software vendor, WellSky, to develop the process for importing the HOMES information into HMIS@NCCEH. Staff recommend focusing the CoC's work to increase HMIS bed coverage on ES and TH programs.



- Staff introduced the ways in which the CoC might set a goal to increase bed coverage.
  - o By number of beds
  - By percentage of beds
  - By CoC or region
  - By Project Type
- Members agreed that setting goals at the CoC-level by percentage and Project Type makes the most sense and to focus goals on ES and TH.
- Members discussed how to set goal percentages. Goals should be realistic but push the CoC to make substantive change in the number of beds for each program type.
- Members set the following recommendations to increase HMIS bed coverage to present to the NC BoS CoC Steering Committee for approval:
  - The NC BoS CoC will increase HMIS emergency shelter bed coverage to 75% by December 31, 2021.
  - The NC BoS CoC will increase HMIS transitional housing bed coverage to 45% by December 31, 2021.







- While this is not as large a stretch goal, members felt that relationships with TH programs were less secure and might take more time and effort. Jane suggested and members agreed to evaluate progress on the TH goal at 6 months to determine if the goal could be increased.
- Members will evaluate progress monthly and make adjustments as needed during the goal period.
- Staff called on a member to present the recommendations to the Steering Committee at the November 3, 2020 meeting. Melissa agreed to present and work with staff on the slide presentation.
- Once the Steering Committee approves the recommended goals, the FPS will work to figure out strategies to meet the goals. Next month's meeting will be focused on these strategies and develop a plan of action to roll out before the end of the year.
- The meeting was adjourned. Next month's meeting will be changed to Thursday, November 19th at 10:30 AM due to Thanksgiving Day falling on our usual meeting day.

### NC Balance of State CoC Nominating Subcommittee Meeting October 16, 2020 Minutes

On its way to developing a 2021 slate of at-large candidates, the Nominating Subcommittee reviewed its efforts to secure representatives from four new statewide agencies since the first meeting. Three of the four have accepted an at-large position and named the following individuals to represent them. Listed next to these are the Subcommittee members who agreed to participate in these introductory calls:

- Isaac Sturgill, Project Director, Housing Unit, Legal Aid of North Carolina (Jim Cox)
- Kelly Ross Benton, President of the Executive Committee for the NC Realtors Housing Foundation (E. Marie Watson)
- Pam Atwood, Director of Housing Policy, NC Housing Coalition (LaTonya Penny)
- Still pending is NC Rural Center, for which a meeting is scheduled on Oct. 21 with that organization's President and Director of Advocacy (Tharesa Lee).

Stephanie Williams with the state's Office of the Senior Advisor on the ADA and Olmstead was proposed by Executive Director Denise Neunaber as a possible candidate. The Subcommittee agreed she should be invited to serve, and LaTonya agreed to be part of that conversation.

The discussion moved to efforts to secure a second at-large member with lived experience. Marie suggested we consider Jeff Rawlings with her organization. Given that Jeff serves as the Coordinated Entry lead from Johnston-Lee-Harnett Community Action, staff was instructed to confirm there would be no conflict of interest since Marie also serves as the Regional Lead (a post from which she says she is stepping down in 2021). If no conflict of interest exists, Kevin will set up a meeting for him and Marie to speak with Jeff about his service on the Steering Committee. To address the challenges in securing someone for this category, Kevin proposed a subcommittee of people with lived experience be established, and those interested in governance could more naturally transition to a Steering Committee seat going forward.

The Subcommittee next reviewed the 2021 slate illustrated in the subsequent table. The slate comprises one additional at-large member beyond the limit of 5 for the "Other with statewide focus" category. Debra asked the Subcommittee to consider a request to the Steering Committee for waiving this category's limit in 2021, given that the slate's total for at-large members does not exceed the maximum of 13. The Subcommittee agreed and will develop and present arguments for why this step should be considered by the Steering Committee.

### **Coordinated Entry Council Meeting**

October 19, 2020 Minutes

Coordinated Entry Data Elements: As of October 1, 2020, HUD-funded SSO-CE projects are required to collect the following three data elements; CE assessment element, CE event element, and current living situation element. Nicole walked the Committee through the three required elements and the "what," "who," and collection state of each. Back@Home Surge Population: Back@Home referrals will happen in two stages. Stage one is the initial surge population and stage two are ongoing referrals through NC 211, with the ESG Office determining the process for ongoing referrals to begin November 16, 2020. The CoC CE Referral Representative workflow is as follows:

- Client identified for Back@Home resource
- Client accepts Back@Home resource
- CoC CE Referral Representative asks the client for NCCARE360 consent and HMIS ROI before sending the referral
- CoC CE Referral Representatives enter surge population referrals into NCCARE360 using the information gathered from paper packets
- Ongoing surge referrals can be entered directly into NCCARE360 without using the paper packets (unless they are helpful for your community's referral process)
- All CoC CE referrals include NCCARE360 HMIS Supplemental Form
- CoC CE Referral Representative makes referral to Back@Home/NC-211 via NCCARE360
- (Referrals will be sent to 211 Data Specialist staff for review)
- NC-211 navigator sends referral to NCCARE360 queue
- NC-211 data specialist sends referral to Back@Home Rehousing Agency through HMIS triage project (using HMIS Supplemental Form)
- NC-211 navigator communicates next steps to client
- Back@Home Rehouisng Agencies will contact households to verify eligibility and enroll in Back@Home-CV in order of prioritization
  - Rehousing Agencies need to inform CoC if there will be a delay in following up with the surge population

CoC CE Referral Representatives are also able to recall referrals (if made to Back@Home Rehousing Agency and not Back@Home/211).
