





# Rowan Helping Ministries requests a letter of support for additional PSH and TH units.

Letter of support would be for HOME-ARP funds

- Assist in development of 5 duplexes (8 1-BR units; 2 2-BR units) for Permanent Supportive Housing
  - On RHM land near other existing PSH units and other RHM services
- Assist in development of 12 TH units specifically for 9 Vets in GPD program and 3 other shelter guest needing these services.
  - Non-congregate units with sleeping space, small kitchen, and private bathroom
  - Reduces risks of COVID-19
  - Already received \$450,000 from VA GPD Capital Grant Program



# NCCEH has completed and submitted the Regional ESG Application.

Designated by the NC BoS CoC Steering Committee, NCCEH has completed and submitted the Regional Application to the NC ESG Office.

- Application was submitted on September 17, 2021.
- All available funds in the Regional Fair Share, \$2,520,285, were allocated.



# Approved Projects submitted documentation to the ESG office by Oct 1.

- 36 agencies approved applications with ESG dollars in CY2022
  - 4 new agencies
  - 32 renewal agencies (some adding new projects)

To our knowledge, all agencies submitted their documentation to the ESG office by the Oct 1 deadline.

Some agencies accepted conditional awards based on participation in TA and changes to Policies and Procedures in CY 2022. NCCEH will be following up with these programs to make a plan for meeting these requirements.



### Improving the ESG Competition process

- NCCEH team will debrief this year's process in the coming weeks. We
  want to hear from you about how to to improve the process for next

  - Improvements needed: communication, clarify confusion around deadlines, Regional Lead roles, and regional prioritization.
- A webinar will be held at the beginning of the competition for all interested applicants.
  - Encourage Regional Leads to attend to ensure consistency of communication to all applicants across the NC BoS CoC.
  - Dates and registration TBD.



#### ESG Orientation webinar required for all grantees.

- For CY2022, all renewal and new grantees will be required to attend an NCCEH webinar for ESG grantees.
- This was formerly required only for new grantees.

# HUD released the NOFO on August 18<sup>th</sup> and set the standards and timeline of competition.

HUD released the Notice of Funding Opportunity (NOFO) on August 18

Final consolidated CoC application due to HUD on Tuesday, November 16<sup>th</sup>

### CoC staff set internal deadlines for review and evaluation.

First submission date: Friday, September 10 at 6 PM

Second submission date: Monday, September 20 at 6 PM

Staff oriented Project Review Committee members on September 17<sup>th</sup> outlining scoring/evaluation process and timelines.

- All new and renewal applications have been scored using approved new and renewal scorecards.
- Staff are in the process of organizing scores
  - Eliminating projects not meeting thresholds
  - Sorting projects by number of standards/section minimums met
  - Ordering by total points in categories

PRC will meet on Thursday, October 7<sup>th</sup> to develop a recommended Prioritization Ranking List of projects to present to the Steering Committee for approval.

- Wednesday, October 20 from 12-12:45 PM: Appeals meeting (tentative)

#### Things to remember:

- We must have a quorum to vote for an approved list!
- Members at agencies applying for CoC should attend but cannot participate in the conversation or vote!



### Staff will complete the CoC Application and may need information.

NCCEH staff will write the CoC-wide Application.

- Staff often need information from stakeholders to complete the application.
- Please respond if you hear from us! We want to include the great things that are happening in your communities.

Staff are aiming to post the final application with the prioritization ranking list no later than November 10.

- We will notify all NC BoS CoC stakeholders when the posting occurs.
- We hope to submit the final application on November 12.



### Recruitment efforts are beginning for 2022




The Racial Equity Subcommittee is beginning a conversation to solidify roles and expectations for new members.

### The NC BoS CoC Data Dashboard has been finalized and ready for use by the Steering Committee!

Funding and Performance Subcommittee started its work to create the dashboard in October 2019

 Purpose: Highlight system/programmatic performance at the CoC- and regional-level to drive strategies to improve performance and end homelessness



# The NC BoS CoC Data Dashboard has been finalized and ready for use by the Steering Committee!

#### **Benefits**

- Measure system performance in real time
- Follow trends of system/programmatic usage
- Understand demographic and household service usage
- Demonstrate inflow and outflow of the system and positive outcomes
- Provide data for the CoC to make decisions/develop strategies and measure effectiveness
- Allow Regional Committees to use data to drive local initiatives using regional and county-level data
- Enhances opportunities to recruit new agencies/projects to HMIS
- Build data literacy

#### Limits

- Includes only data from HMIS participating agencies
- Includes only data from standard programs:
   SO, ES, TH, RRH, PSH, HP, and CE
- Includes only CE data on the CoC/Systems Tab
- Presents data as input into HMIS data quality matters!

# The Steering Committee will start using the dashboard at the November 2021 meeting.

Staff will begin using the dashboard next month . . .

- Slow rollout starting with CoC-level data looking at some key data points
- Highlight new data points each month
- Become more sophisticated over time as members become more comfortable with the dashboard and the data
- Intentionally rollout the dashboard to Regional Committees in mid-2022

Funding and Performance Subcommittee will dig deeper into the data and bring recommendations to the Steering Committee for consideration.





# **Digital Divide to Digital Equity**




"At least 1.1 million NC households lack access to high speed internet, cannot afford it or do not have the skills needed to take advantage of the digital economy"

# Federal Advocacy


- Infrastructure Investment and Jobs Act: \$65 billion for infrastructure, affordability, adoption
  - About \$42.5 billion for states and territories to work with ISP to expand network in under and unserved areas
  - \$14 billion for subsidies to low-income Americans to pay for internet service
  - \$2.75 billion for the **Digital Literacy Act**





# How are these benefits provided?

Those who signed up to receive Economic Impact Payments ("stimulus checks") from the Internal Revenue Service will now automatically get the Child Tax Credit as well.

Those who have never filed for or received any of the Economic Impact Payments will receive all their unclaimed stimulus checks once they file for the Child Tax Credit!

# Example–Family of 1 Parent and 2 children (ages 5 and 12) with no/low income

Are not required to file a 2020 tax return, didn't file one, and never filed for the 3 Economic Impact Payments

- \$3,000 CTC for child over age 6
- \$3,600 CTC for child under age 6
- \$5000 for both children in unclaimed EIP
- \$3,200 for the parent in unclaimed EIP

**TOTAL VALUE: \$14,800** 



# Automatic Monthly Payments through December 2021

People will receive half their CTC in monthly payments from July through December 2021 and receive the other half when they file their taxes in 2022.

Deadline to file to receive advanced monthly installments:

November 15, 2021


People who get IRS refunds through direct deposit will get the CTC in their bank account on the 15th of every month.

People who don't use direct deposit will get payment by mail around the same time.

### Help Is Here

### Monthly payments for families with kids

Raising kids can be expensive, and the Child Tax Credit is here to help. President Biden's American Rescue Plan increased the amount of the 2021 Child Tax Credit to support families with children.

The full benefit of the Child Tax Credit is now \$300 per month per child under age 6 and \$250 for each child age 6 to 17.

### Did you file taxes in the last 2 years? Then you don't have to do anything to get the money you're already owed!

If you filed your 2020 taxes this year or filed your 2019 taxes last year, or used the IRS "Non-Filer Portal" to get a stimulus check last year, you don't need to do anything. The IRS will automatically send you a monthly payment by direct deposit or check starting on July 15, 2021.

### The Child Tax Credit is \$3,000 to \$3,600 per child with advanced monthly payments.

In order to get money to families quickly, the IRS will pay half of the credit as monthly payments now and the other half when you file your taxes next year. In total, you'll receive a total of \$3,600 for each child under 6 and \$3,000 for each child between 6 and 17.

### Didn't file taxes in the last 2 years? There's 1 easy step to start getting your Child Tax Credit payments.

Just fill out a simple form to begin receiving your monthly Child Tax Credit payments. You can access it by going to childtaxcredit.gov

#### All you'll need to apply are:

- A reliable mailing address
- E-mail address
- · Your children's Social Security Numbers
- Your Social Security Number (or ITIN)
- Your bank account information (if you want to receive your payment by direct deposit)

Eligibility: Most families, even those with little to no income, can receive the full amount. If you are a single parent making less than \$112,500 or a married couple making less than \$150,000—and have children under age 18 who will live with you for more than half of 2021—you are likely eligible for the full benefit. These benefits do not affect your eligibility for other federal benefits like SNAP.

# What NCCEH network could do if Congress expands the CTC benefits past 2021!

- Get Governor's Office to direct state revenue agencies to identify adults in families with children who have not filed taxes but who are enrolled in public benefit programs--such as TANF, SNAP, Medicaid, and WIC and target outreach to families who need to file to receive the Child Tax Credit.
- Partner with VITA operations to assist filers for the CTC.
- Use American Rescue Plan resources at state and local levels to fund targeted outreach campaigns and help individuals file.
- Partner with United Way/211, Medicaid pediatricians, and WIC offices to run video loops in waiting rooms with phone app/instructions for filing.
- Partnerships with faith-based leadership and legal aid to assist immigrant parents.
