



Strategic Planning

SSA

- Timely response sending out decisions (also not processing timely in terms of getting to DDS)
 - Cases sitting in quality review (21 day limit)
- 3288 and 1696 forms uploaded in a timely manner
 - Prompt 3288 response including DLI and prompt access to prior decisions
 - Electronic 1696 on file (why paper needed)
- Uniform answers/processes
- Increasing knowledge of SOAR at FOs
 - Selecting liaisons that are SOAR trained and understand the process
- Supporting SOAR worker opinion on claimant needs
- Payee requirements/needs
- Be notified that claim received
- Access to ARS so we don't have to wait



DDS

- Improving streamlining between DDS-SSA-SOAR
 - DDS being able to receive 1696s
- Ordering CEs automatically when not needed
- Better monitoring of CE providers
- No more evidence needed but will 45-60 days for decision
- Customer service long wait times
- Return phone calls
 - DDS examiners better respond to SOAR reps and understand we are seeking to help them not bother them
- Distance to CEs (getting travel vouchers working)
- Holding up a decision waiting for medical records that cannot be obtained
- Pay attention to ERE and stop sending to CE because the ERE hasn't been checked



Referral Networks

- Less strict guidelines for grant funded SOAR workers
 - Hands tied due to contract goals, need a certain amount of winning cases
- Access to SOAR reps in other states for info on what works/does not
- Shared list of who is accepting SOAR cases and referral criteria
 - How many people are taking external referrals
- County/city funded SOAR workers



Resources

- On site medical treatment for clients with no benefits
- Insurance and 401k for SOAR workers
- Medicaid reimbursement for SOAR workers



Data

- Why claims are approved/denied by DDS the most
- How's VPAP? Data should be available to the public
- Link Point in Time number to SOAR
- Volume of SOAR cases that are processed annually
- What claims have co-occurring disorder with substance use
