





Lived Expertise Advisory Council

July 14, 2023, Minutes

Attendance: Rachelle Dugan, Tonya Parker, Joel Rice, Melissa Hewitt, Laurel McNamee (staff), Elliot Rhodes (staff), Emily Carmody (presenter)

Introductions: Elliot Rhodes from the NCCEH Data Center introduced himself, and Rachelle provided background on the work of the LEAC.

Celebrations: Melissa has been approved to join the Steering Committee for the remainder of 2023! Emily also shared that LEAC feedback has already made an impact in the workflow design for SNOFO implementation at NCORR.

Client Bill of Rights: Further discussion of how to strategically prioritize which regions to start working with. Laurel proposed starting with the regions where participants are active. LEAC members discussed how many people would attend each one. The group agreed that targeting regions that already have LEAC representation to start made sense, and concluded that sending 2 people to each meeting would be the simplest, targeting 1-2 regional committee meetings per month beginning in October.

Back@Home BoS: Emily Carmody returned to continue presenting and seeking feedback on the implementation of the Back@Home BoS program (the new name for the SNOFO funded initiative). An RFA is out now to find agencies that will be service providers. Emily presented a workflow on service navigation and noted that there are 2 ways clients can be enrolled in Back@Home BoS. LEAC members expressed a nervousness for the continuity of services and communication between case managers and clients, and a desire to ensure comfort with providers and continuity of communication throughout the experience. Emily then presented a workflow on the intake and orientation process. LEAC members provided feedback asking for clarification on what will be asked of people coming into the program and the communication plan for maintaining contact between client and case manager during the housing process.

Next Meeting: Laurel noted that she will not be in attendance for the August meeting, and will start an email with Andrea Carey, who will facilitate, as well as Emily Carmody, and LEAC chair Alyce Knaflich to set an agenda.

Racial Equity Subcommittee

July 19, 2023, Minutes

Celebrations / Announcements:

Andrea asked for attendees to share personal celebrations since the last meeting and other important announcements.

2023 Racial Equity Assessment:

Andrea Carey presented the “2023 Balance of State Racial Equity Analysis – Final Data Review” to the workgroup. The presentation covered key findings of the 2023 Racial Equity Analysis.

Members discussed the history of the Racial Equity Analysis and the way that HUD has incentivized its publication. The commitment has been integrated into BoS official policy, regardless of the CoC NOFO moving forward.

While the 2023 REA findings continued to align with previous year’s data, this year’s analysis was the first time data was able to be presented at the Regional level. Specifically, comparing regional Census demographic data to regional PIT homelessness data. As a result, a few clarifying questions were asked:

- Clarify or explain Region 6’s high Native American / Alaskan percent share of homeless population when the Census data suggests this racial group represents a very small portion of overall population.

A comment was made during the meeting about the reliability of PIT data responses due to a potential lack of trust. Are vulnerable persons willing to share full and accurate information about their homelessness experience during a PIT survey? And if not, how do we adjust for that?

Stella P data from the Longitudinal System Analysis limits the analysis to ES, TH, RRH, and PSH enrolled clients, but can be compared year over year to track progression or regression of racial equity. In particular, the Length of Time Homeless metric shows that clients identifying as black experience homelessness a month longer than all other identities. Special consideration of this metric after the CE Assessment is replaced will be needed by the Racial Equity Subcommittee.

Review of the data presented concluded and next steps discussed. The members felt that waiting until the August meeting for a vote was better than using an email vote.

To Discuss Next Month:

- Review the strategies and action steps for the Racial Equity Analysis and vote on whether to send it to the NC BoS CoC Steering Committee.
