



Lived Expertise Advisory Council September 8, 2023, Minutes

Attendance: Alyce Knaflich, Rachelle Dugan, Joel Rice, Jaime Stepp, Laurel Benfield (staff), Elliot Rhodes (staff)

Membership and recruiting update -

Alyce shared that she is planning on stepping down from the LEAC, and many of her other CoC related roles, as she moves toward retirement and creates more space in her schedule. She will stay on the LEAC until the end of the year. The group congratulated her and thanked her for her service.

CoC program competition (LEAC certification of representation of PLE is required)

Laurel presented a draft of a letter to include in the CoC Program Competition certifying that the LEAC exists and supports the NC BoS CoC to use CoC Program funding to prioritize the most vulnerable in each community. The group asked questions about how the letter would be used and how it would be linked to their personal identity and career. All present agreed to review and sign the document after a review.

Preparing for Client Bill of Rights trainings -

The group discussed planning for presenting information on the Client Bill of Right (CBoR) to Regional Committees, starting in October. Alyce confirmed that the LEAC is on the agenda for the Region 02 Committee meeting on Oct 5th. Laurel noted the need to include recruitment in the planning for these presentations, but not in Region 2, since membership from this Region is strong. Laurel will send the CBoR document and link to the recorded training to Regional Lead Emily Lowery for distribution ahead of the regional committee meeting. The expectation will be that agencies review the policy ahead of the meeting and come prepared for discussion. Staff suggested moving to regions in Eastern NC after October to include recruitment for the LEAC as an agenda item. Joel agreed to look into presenting in Region 09 for November, and staff will identify a second region as well. The agenda for each presentation is as follows:

Discuss the policy, reinforce its importance.

What you need from providers: post the CBoR, train their staff on the policy and its implications.

Laurel: we want to step outside the conversation about how there isn't enough affordable housing, we want to discuss options, new ideas, novel approaches.

Christina: Rowan County police department homeless liaison, share resources, gather information, build relationships. Have funds to relocate to family members. Rowan Helping Ministries is immediate shelter growing space with transitional housing. Received donation of older buildings being retrofitted to apartment units. Bonnie: more talk about shared living, PSH program has done for 2 households. Takes a lot of work to have roommates, get individuals agree to shared living (a lot of people don't want that) but there are more 3-4 bedroom homes than 1-2 bedroom homes. Why providers don't offer classes about how to be a good roommate. Individuals with trauma, need to address that, support that.

Laurel: Allie & Laurel hosting forum for providers in emergency shelters on that topic the week before next RE Dialogue

Dr. Cole: study from 1998 about veteran shared housing, housing people with similar trauma,

disaster. People not taking medication one of the biggest issues.

Dr Cole: Wake County buying extended stay hotels, converting to PSH.

Analysis Next Steps, Group Check-in: 20 minutes

Racial Equity Analysis: Action Steps Naming impacts of committee:

Racial Equity Subcommittee impact

- · Racial Equity Dialogue Series:
 - 12 events since 2020. Average attendance of over 50 people.
- Equity section in competition scorecards:
 - All applicants for both CoC and ESG submit responses based on their equity efforts.
- · Racial Equity Analysis:
 - Annual dive into our data to determine where there are disparities and where the CoC should focus its efforts.
- · Racial Equity Core Team:
 - Working to replace the VI-SPDAT

Christina on future work: barriers with social security card, birth certificates, barriers getting documentation. Blaming people once they turn 18 for their circumstances – how do we prevent abuse and get people empowered and tools they need to break cycles. Individuals who come from out of town seeking services, want to invite them into conversations. People without experience trying to make the decisions. Have individual relationships with housing authority, apartments to house people, seeking help shaping policies to formalize those informal practices.

Laurel: discussion of lived experience advisory committee, recruiting in eastern NC, looking for representation from people of color, collaboration is possibility.
