Approval of June Minutes

There being no changes needed, the minutes were approved by common consent.

Revised NC BoS Governance

- In order to be compliant with the HEARTH Act interim rule, the Steering Committee must ratify a
 document that lays out the governance structure of the CoC. The document must describe roles
 and responsibilities for Steering Committee members and CoC staff; the CoC's procedures for
 funding applications; responsibilities for data collection, assessment, and reporting; and CoC
 planning.
- Corey has revised the draft document to include the following changes, as discussed at the June meeting:
 - Revised mission statement
 - o Regional committees will elect a Regional Lead and an official alternate
 - Barring a conflict of interest, official alternates will be able to vote in the absence of the
 Regional Lead, or if the regional lead has a conflict of interest and is unable to vote

- Staff asked that Regional Leads distribute this document to Regional Committee members and submit feedback to bos@ncceh.org by July 26.
- Staff will present a third draft of the document at our next meeting on August 6 and either vote to approve or consider further changes and discussion at that time.
- Regional Committees should begin the process to elect an official alternate this must be reflected in Regional Committee meeting minutes.

Data Usage Workgroup

- At our last meeting, the Steering Committee discussed the revised CHIN Cost Structure and agreed to pilot a program for one year starting July 1, 2013 wherein BoS pays the total cost of the CHIN CoC fee. We agreed to form a Data Usage Workgroup to:
 - Target the CoC's available licenses to agencies that are not on CHIN yet; Denise noted
 that for the targeting we will likely look for the best "bang for our buck" to improve our
 HMIS bed coverage in the NC BoS CoC application this will likely mean emergency
 shelters and transitional housing
 - Create a policy for users who receive no-fee licenses re: standards of data quality and use
 - Create evaluation criteria for a revised policy for no-fee licenses in FY 2014-2015

 Regional Committees can opt to use this form to help organize expected ESG applications, but it is not required. NCCEH will share intent to apply submissions with Regional Leads.
