## Referring community agencies have several roles in the program.

- Who are referring agencies?
  - Community-based agencies that provide support services to people with disabilities
- Services to provide:
  - Assess the needed supports and services to maintain permanent tenancy
  - Make referrals for individuals to the Targeting Program
  - Assist persons in the application process, including requesting reasonable accommodations and modifications
  - Provide ongoing and voluntary supportive services to Targeted unit tenants with the goal of permanent tenancy



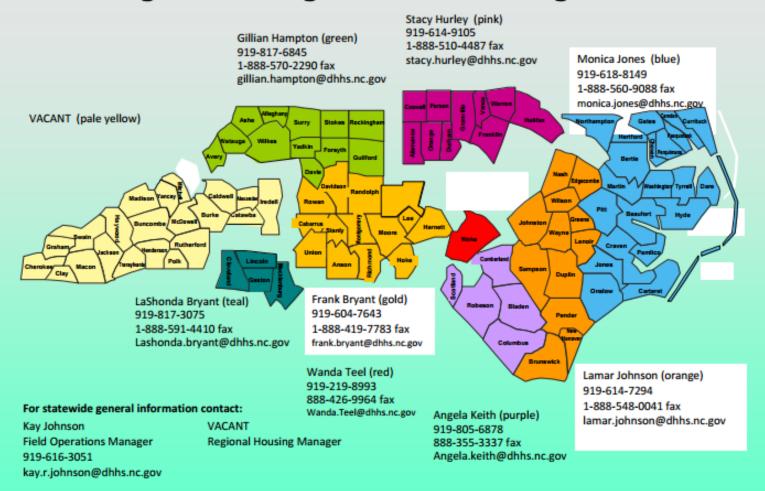
## Regional Housing Coordinators manage the referral process.

- NC Dept. of Health and Human Services, Division of Aging and Adult Services has 9 Regional Housing Coordinators (RHC) across the State to manage the referral process for tenancy in the Targeting program
- Interested Agencies should contact the applicable RHC for information on becoming a referral agency
- Referral Agencies may be nonprofit agencies, Local and State Government agencies, and other programs that have the capacity to support individuals in housing

## Collaboration with Public Housing Authorities

## HUD brings NC PHAs together to end homelessness

- HUD sponsored a meeting with PHAs on September 21 to:
  - Hear HUD's priorities on ending homelessness
  - Listen to a panel of CoC leaders and other PHAs that have implemented strategies to use public housing and Housing Choice Voucher resources
  - Connect PHAs to CoC representatives



## PHAs and Regional Committees need to collaborate

• PHAs offer the largest stock of affordable housing in most Balance of State communities

#### System of mutual support

- Housing service providers can assist PHA residents with deposits to move into housing and the follow-up services to help PHAs reduce recidivism
- PHAs can provide an affordable housing option for homeless individuals and families and reduce barriers to housing such as:
  - Poor credit
  - Criminal history
  - Bad rental history such as evictions
  - Lack of substantive income



## PHAs and Regional Committees need to collaborate

- So how do you start?
  - Create a relationship. Take the time to get to know and understand one another.
  - Identify your respective needs.
  - Develop strategies that could help, such as:
    - PHAs develop a homeless preference, general or specific
    - PHAs set aside a certain number of public housing units or Housing Choice Vouchers for providers
    - Providers offer to case manage homeless households moving into public housing
    - Project-based rental and supportive service assistance



## Focus on the Brevard Housing Authority's strategy

- The Brevard Housing Authority worked with Regional Committee leadership to develop a preference for homeless individuals and families.
  - From the Brevard PHA workplan:
    - Based on needs identified in the consolidated plan and on consultation with local partner agencies, the PHA provides a preference for families and individuals who are homeless, as defined either by HUD or for McKinney-Vento purposes, and who will be receiving regular on-site housing case management services from a local homeless services, domestic violence, social services, school social worker, or mental health agency for at least 6 months after moving in. This preference will be verified by the agency that commits to provide case management.

### **BoS Governance Charter**

# HUD requires annual updates for CoC governance charters.

Last update was made in November 2015

- BoS staff have reviewed governance charter and made updates to reflect current activities
- Draft of governance charter & summary of updates sent out last week for Steering Committee members to review

## Proposed updates make the charter current and more clear.

- Replaced old written standards with new ones
- Added description of Regional Committee restructuring process and added map & list of new committees
- Added new Regional Committee leadership roles (CA, PIT Count, funding committee, webmaster)
- Added new subcommittees (CA Exchange, veterans)
- Updated terms and dates for accuracy:
  - Changed collaborative applicant from DHHS to NCCEH
  - Changed date of approval for written standards
  - Made minor changes to language for consistency/clarity

#### 2017 Point-in-Time Count & HIC

# 2017 PIT Count & HIC will be the night of Wednesday, January 25.

- Point-in-Time Count = homeless count
  - Emergency shelters
  - Transitional housing
  - Unsheltered (sleeping on streets, parks, cars, abandoned buildings, bus/train stations, encampments)
- Housing Inventory Count = inventory of homeless programs
  - Emergency shelters
  - Transitional housing
  - Rapid re-housing
  - Permanent supportive housing



## Regional Committees plan and conduct local counts.

- Getting agencies involved who need to do sheltered count
- Planning locations for unsheltered count
- Training volunteers
- Distributing PIT/HIC forms to agencies & volunteers
- Advertising count so homeless people know it's happening
- Collecting completed PIT/HIC forms, de-duplicating, and reviewing for correctness
- Submitting forms to NCCEH by deadline



# The 2017 PIT/HIC will be done within your new, restructured Reg. Cmtes.

- Start planning process as soon as possible
- Involve agencies and stakeholders from all areas of new RC
  - May tweak existing process or create new one
- Create a PIT/HIC committee to plan and prepare for count
- Select a PIT/HIC lead contact
  - Will be the point of contact for NCCEH to send info and ask questions about local count data

# NCCEH provides PIT/HIC forms & training.

- NCCEH creates forms for collecting PIT/HIC data
  - Use 2017 HUD guidance to capture all required data
  - All RCs should use NCCEH forms please do not create your own

## **ESG Application Update**

## The ESG application has been released.

- The ESG application and instructions were released on Friday, September 23<sup>rd</sup>.

- Application consists of two parts:
  - Regional application that asks for information for your Regional Committee and the full CoC.
  - Project applications for each individual project recommended for funding.



## Regional Committees should begin running their local process right away.

- Two deadlines for the ESG competition this year
  - Agencies intending to apply for ESG funds this year must send in all contract certifications by October 7<sup>th</sup>.
  - The full regional application with corresponding project applications must be postmarked or hand-delivered to the ESG office by **October 21**<sup>st</sup>.

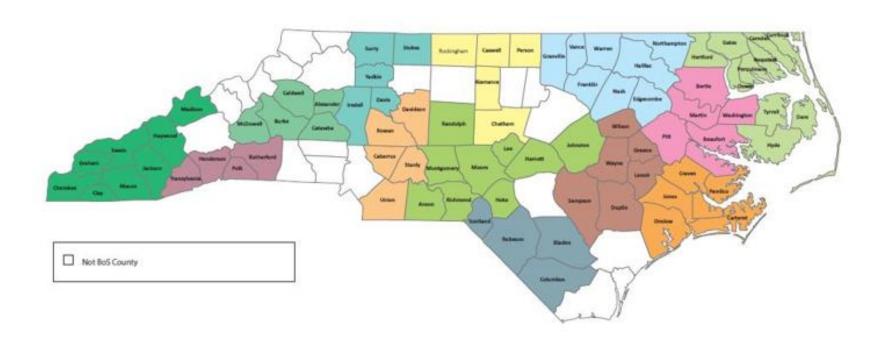
- Regional Committees will submit data

## The Annual Homeless Assessment Report

Report to Congress on the extent and nature of homelessness in the United States

The central resource for national data on homelessness

420 CoCs nationwide included

AHAR submission tied to CoC Application funding



### What does the AHAR do?

Estimates the number of homeless people in US

- Characteristics of homeless people in US
- Service use patterns
- Estimate capacity to house homeless people

Estimates the number of people in PSH

Characteristics of people in PSH

Helps to better understand the number, characteristics, and service needs of people using residential homeless services in your community

## What HMIS client data is included?



October 1, 2015 to September 30, 2016 (12 months)



Any person who entered ES, TH and/or PSH during reporting period (note: RRH not included at this time)



Data is reported for individuals and persons in families



Data about veterans is reported

## Submitted data is evaluated for usability



#### Coverage

At least 50% of the beds in a category must be participating in HMIS.



#### Utilization

Bed utilization rates must be between 65% to 105%



#### **Data Quality**

Low rate of missing data

Data reflects what is valid

Information is consistent across time

## Areas of Concern

Utilization rates over 105% in PSH	Contact Data Center to update inventory

Reporting Category	Reason for Concern
Transitional Housing- Individuals	Bed coverage rate is 38.82% This is below HUD's standard of 50%
Summary- All Persons	All categories must be accepted

## Data must be cleaned prior to submission

The NCCEH Data Center will be in touch with a timeline and additional instructions about data corrections for your agency

Agency Admins are key to a successful submission!

- Be responsive to the NCCEH Data Center
- Run and review reports
- Work with staff to correct errors each week leading up to final AHAR submission
