Agency Updates/What's Happening

Union- Thrive Union is the taskforce in the area. Has evolved into subcommittees and groups. Meets monthly. Union Shelter is currently full and operates off of waitlist.

Cabarrus- Jim H. and Opportunity House /group to bring together how to get those access to community resources. No shelter in Cabarrus to serve their homeless community. Several different agencies that refer people to Teresa.

Davidson- New shelter being built, to double capacity. MaryAnn only CM, getting an assistance. Fundraiser is a pancake breakfast. Sal. Army to donate the land beside them. Still will be downtown with resources. Social Services to have office in their building.

Rowan- Met with housing authority, East Spencer. Partnership to do job fair. Intake specialist now at the shelter to do breathalyzer, drug testing. Responsible for the prevention/diversion sheet.

Stanly- 16 bed shelter, 12 is busy. No family rooms. Been getting a lot of individuals with substance abuse. BBQ fundraiser 9/27. Money goes directly to community. Transitional housing, all houses are filled right now. PSH filled on 4th street. 2 PSH homes.

Stanly -(Andrea Merriman) – DV shelter Esther House. Renovating main shelter. Have a building on 2nd shelter for just human trafficking, to be up by the end of the year. Will have 8-12 beds for human trafficking victims.

Volunteers of America- get referrals from CE, doesn't make referrals.

Side note ** Low Barrier does not mean you have to have unsafe people in your shelter. Everyone should have access to help. Low Barrier DOES NOT MEAN you have to put yourself in danger. If someone is a safety risk, you can ask them to leave. **
