Minutes

Introductions

• The meeting was called to order and those in attendance introduced themselves.

Approval of Minutes

• The committee reviewed the minutes from November's meeting. There was one change. There was a typo under the SSO-CE Grant section. The sentence read, "A person has been fired for the position" and it should have read, "A person has been hired for the position". After the correction was made, Mrs. Teresa Forward made a motion to approve the minutes and it was seconded by Mrs. Carolyn Copeland.

Balance of State Steering Committee Updates

- Reminder the PIT Count will take place Wednesday, January 29, 2020
- Things to think about when planning conducting an unsheltered count:
 - Start planning early
 - Engage agencies/organizations/groups in the community that might come into contact with this population
 - Law enforcement
 - Soup kitchens/food programs
 - Outreach programs: i.e. SSVF programs
 - Youth providers
 - o Build a list of known or potential locations where people living unsheltered might be
 - Advertise in the community
 - Solicit for and train volunteers

- The unsheltered population is the most vulnerable that we serve because they are not accessing emergency housing of any kind and may not be accessing services at all.
- PIT/HIC data is an important tool and resource for your communities
 - o Inclusive count of homeless populations
 - o Includes non-HMIS agencies
 - Includes unsheltered homeless populations
- Can use local and regional data to:
 - o Understand size and scope of the homeless population
 - Assess system for gaps
- Do your programs match the needs of your population?
 - o Track increases or decreases
 - o Locate and engage unsheltered homeless populations
 - o Raise community and political awareness of homelessness. The PIT count provides a snapshot of the system on any given night.
- What we are counting:
 - Beds and units
 - What capacity do we have to provide emergency shelter and transitional housing?
 - What capacity do we have to provide permanent housing like rapid rehousing and permanent supportive housing?
- People
 - o How many people are experiencing homelessness?
- Counting Us App
 - o The App is different from last year's app. The back end will be more streamlined so staff can collect data and report it back quicker to Regional Committees than last year
 - New/Improved from last year
 - Used nationwide
 - Includes expert technical support
 - o Includes all questions required by HUD
 - o Can be used on phones, tablets, computers
 - Low-barrier access and use (does require sign-up)
 - o Ongoing training dates for everyone starting in November
 - o Available for agencies and volunteers to practice with starting in mid-November
 - o App will "go live" on the night of the count around 6pm
 - o Data submitted will be immediately able to be viewed, allowing for quicker response and reporting

Rapid Re-housing/Street Outreach Update

- The committee's Coordinated Entry Plan need to be updated as soon as possible
 - Must be done by January 1st
 - o The plan will be sent to the entire committee for review and comments
- River City stated that they need assistance with verifying homelessness, possibly a 3rd party to
 actually verify homelessness; they are also planning to start the implementation of the two
 programs on January 2nd
- If anyone knows of any landlords or rental properties, please share them with River City

A discussion was had about the importance of the By-name list and having it as up-to-date as
possible. The list is where River City will get all of their referrals for the Rapid Re-housing
program

PIT Count

- Tyrrell County DSS is willing to assist with the count
- Reached out to people in Hyde County have not received a response
- Shelter count shelters are able to enter in their own data
- Trainings are available on how to use the app
