




Camera

Defining Racial Equity Subcommittee



Statement of Purpose

The purpose of the Racial Equity subcommittee is to identify

areas in NC Balance of State Continuum of Care's policies that

may contribute to racial disparities in access to and services from

the homeless system and to recommend changes to them.



Goals

The subcommittee has several immediate, actionable goals:

- 1. Ensure that the COVID-19 response is equitable in BoS
- 2. Ensure that the CoC Scorecard has a racial equity focus
- 3. Ensure that the annual racial equity assessment is completed

Strategies for creating an equitable COVID-19 response system

- Have the right people in the room
- Engage distrustful communities via outreach
- Housing First!
- Stay focused on current system goals
- Stay focused on racial equity
- Rest! Rest! Rest!
- Get accurate data



Interagency Council on Coordinating Homeless Programs (ICCHP) Priorities for COVID-19 Response

- 1.Crisis Response
- a. Sheltered Settings
- b. Unsheltered Settings
- c. Non-congregate Shelter
- 2. Housing Stability
- a.Prevention
- b.Diversion/Rehousing (Back@Home)
- c.Long-term Assistance
- d.Direct Landlord Relief



CoC Competition Scorecards



Why do we score and rank applications?

- Allows CoC to prioritize funding based on HUD and CoC priorities and need
- Ensures CoC prioritizes funding for projects that have high performance and manage funds well
- Required by HUD in application process

The Scorecard Committee creates scorecards for new & renewal grants.

4 Goals of Scorecards:

- 1. Fund organizations that have the capacity to run effective programs
- 2. Fund projects that reflect the NC BoS CoC & HUD's priorities
- 3. Incentivize agencies to be good partners
- 4. Ensure that funded projects are being good stewards of NC BoS CoC funding and performing to NC BoS CoC standards



The Project Review Committee will score and rank project applications.

- Goal: To review and score renewal and new grant applications and recommend a ranked list of projects to the Steering Committee for final approval.
- The projects will be listed in ranked order and divided into 2 tiers as HUD outlined with funding amounts.
 - Projects in Tier 1 are conditionally awarded as long as HUD thresholds are met.
 - Projects in Tier 2 are at greater risk for not getting funded.
