




#### **CoC Competition Update**

Awaiting information from HUD regarding plans for the FY20 CoC Competition.

HUD staff on a recent HUD COVID-19 Office Hours call reported that the SNAPS office is advocating for a non-competitive CoC Program funding process this year. This requires Congressional approval. The U.S. House of Representatives passed a new version of the HEROES Act this week that includes a provision to cancel the FY20 CoC Program Competition and renew existing CoC grants. This bill will be considered by the U.S. Senate. With the current Congressional schedule, any new COVID-19 relief bill will likely not be approved until December. CoC staff will continue to update the Steering Committee and other NC BoS CoC stakeholders as more information becomes available.

#### **Racial Equity Assessment-Next Steps**


Steering committee formally adopted RE assessment Proposed action step: have educational sessions with our own agencies, maybe we create an outline or factsheet so people can share within their own agencies Key areas of action from assessment:

Collaborative and inclusive dialogue and action

- Need to recruit more racially diverse members (in particular non-black POC)
- Maybe focus on our subcommittee first and later focus on larger steering committee
- Decision-making tool to guide governance: we have some examples like from Durham Data collection and assessment
  - Analysis could be more intersectional
  - Analysis could be more regional
  - Qualitative data needed
  - Maybe collaboration with city government (e.g. quality of life data re neighborhoods)
  - Looking at agency client satisfaction data, maybe CE annual evaluation data
- Figuring out a way to address getting data from folks who are not engaging our services Training and support- ran out of time to discuss deeply

Do we want to think about quarterly meetings to address top priorities in upcoming year? Next time we can identify priorities and assign



#### NC BoS CoC Nominating Subcommittee Meeting September 18, 2020 Minutes

Attendees: LaTonya Penny, Jim Cox, E. Marie Watson, Tharesa Lee, and Debra A. Susie

Having served on the 2019 Nominating Subcommittee, Jim Cox and LaTonya Penny shared some basics about the subcommittee and its charge--

- The NC BoS CoC Steering Committee membership comprises Regional Committee leadership and at-large seats.
- In 2017, the Steering Committee approved a restructuring proposal that added the at-large seats, which do not directly represent any single Regional Committee. In fact, at-large members with statewide networks or constituencies are preferred.
- Having at-large members on the SC is designed to provide collaboration between the at-large member's agency/sector and the NC BoS CoC to better serve people experiencing homelessness.
- Elected annually for one-year terms, starting in January.

The subcommittee agreed to pursue a three-step process over three meetings towards the goal of presenting a 2021 slate of At-Large Members at the December Steering Committee Meeting for approval.

- Consider 2020 At-Large members who have expressed interest in continuing to serve in 2021.
  Staff will follow up with an invitation to return or to thank them for their service, depending upon the Nominating Subcommittee's directive.
- Review vacant at-large member positions and identify sectors not represented on the slate for 2021 in the context of representatives positioned to enhance the work of the NC BoS CoC next year.
- Staff will schedule and members of the Nominating Subcommittee will participate in conference calls with identified prospects to discuss the responsibilities and expectations of At-Large members to determine interest in and availability for service in 2021.

Members first reviewed the 2020 At-Large members for meeting attendance and engagement through subcommittees and working groups. All but one had attended at least 7 out of 10 Steering Committee meetings in 2020; and most expressed an interest in remaining on the SC through 2021 (shaded in yellow below). A review of the categories of At-Large members followed with the help of the following table, which identified the minimum number required in each category and where there were open spots to fill.

Subcommittee members agreed we should pursue these prospects and also secure the NC Housing Coalition's Pam Atwood, Director of Housing Policy. Given Angela Harper King's active role in more than one subcommittee/work group, Debra was asked to phone Angela to confirm whether she will not serve another year or just missed the email. All those who asked to serve another year will be invited to do so, and an email will be sent to the rest thanking them for their service.

Before adjourning, the subcommittee members each agreed to 1) approach leaders in their regions for prospects with lived experience who may sit on their shelter boards or work as volunteers; and 2) participate in one prospect's exploratory call and report results back at the next meeting on October 16. Debra will schedule these meetings.
