
## Our goal for 2021

The NC Balance of State CoC will complete an accurate and comprehensive Point-In-Time and Housing Inventory Count to understand the scope of homelessness and resources available in the CoC.

# **PIT/HIC data is an important tool and resource for your communities**

#### Inclusive count of homeless populations

Includes HMIS participating agencies

Includes non-HMIS participating agencies

Includes unsheltered homeless populations

#### Can use local and regional data to:

Understand size/scope of homeless populations

Assess system for gaps (do your programs match your populations needs?)

Track increases/decreases


Locate and engage unsheltered homeless populations

Raise community and political awareness of homelessness

Understand the impact of the COVID-19 pandemic on homelessness



#### Point-In-Time Count (PIT)

Count of people experiencing homelessness on one night

#### Housing Inventory Count (HIC)

Count of the beds in the homelessness system

Temporary: Shelters and Transitional Housing


• While here, people are counted as experiencing literal homelessness in the PIT

Permanent: Rapid Rehousing and Permanent Supportive Housing

• While here, people are not counted as experiencing homelessness – they are formerly homeless after moving in! We still use the surveys to inform our reports!

## **Point-in-Time Count (PIT)**

Snapshot count of people experiencing homelessness (HUD Definition)


#### **Unsheltered Count**

People staying in places not meant for human habitation

Outdoors (streets, park benches, under bridges, etc.) Tents/Encampments Vehicles Bus or train stations Abandoned buildings

#### **Sheltered Count**

People staying in **emergency shelter** or **transitional housing** dedicated to people experiencing homelessness





## What programs are included in the sheltered PIT?

#### **Emergency Shelter**

- Year-Round Shelters
- Seasonal (cold weather) shelters
- Domestic Violence Shelters
- Hotel/Motel Programs

#### **Transitional Housing**

## Must be <u>dedicated</u> homelessness programs that provide a temporary place to stay:

- 1. Primary intent is to serve people experiencing homelessness
- 2. Homelessness is an eligibility requirement
- 3. Actual program participants are predominantly experiencing homelessness

## The CoC will use the Counting Us App for non-HMIS participating shelter programs.

- Same App used last year
- Used nationwide
- Includes expert technical support
- Includes all questions required by HUD
- Use on phones, tablets, computers
- Low-barrier access and use (does require sign-up)
- Ongoing training dates for everyone starting in January
- Available for agencies and volunteers to practice with starting in January.
- App will "go live" on the night of the count
- Data submitted will be immediately able to be viewed, allowing for quicker response and reporting







# The CoC will adjust its unsheltered PIT plan for 2021 due to the ongoing pandemic.

HUD released 2021 PIT/HIC guidance on Friday, 11/13.

- Sheltered counts will happen normally.
- Unsheltered counts can and should be adjusted for safety reasons due to the ongoing pandemic

The CoC unsheltered PIT plan calls for using current CE systems to count people living in places not meant for human habitation rather than planning for a one-time street/services count.



# As designed, CE systems should be accounting for all people living unsheltered in the region.

Regions are not currently accounting for all people living unsheltered on the By Name List but should be working towards this.

The PIT Count can help!

Starting early through special efforts for the PIT Count can help the CoC meet two requirements and provide better services to people living unsheltered!

- Provide a comprehensive and accurate By Name List
- Count all people living unsheltered in the CoC
- Ensure all people experiencing homelessness are connected to CE



# Regions can facilitate a medium-term plan to get folks counted and connected!

- Emphasis on outreach efforts over the next two months leading to the PIT Count date on 01/27/2021
  - Plan canvassing days to do street outreach when feasible
  - Get service centers involved
  - Refer all unsheltered individuals to the By Name List
- Advertising to the community
  - People experiencing unsheltered homelessness
  - Agencies serving people living unsheltered
- Verify people living unsheltered on PIT night between 01/28 02/09
  - Use By Name List to confirm status on 01/27/2021



# Counting people living unsheltered through the CE system provides multiple benefits.

- Strengthens required existing infrastructure
- Connects people to the CE system, ensuring they get services and access to permanent housing
- Focuses on connection to resources and services
- Allows a longer period to find and count people experiencing unsheltered homelessness
- Gives opportunity to incorporate existing safety protocols to keep clients and staff/volunteers safe
- Requires fewer immediate resources to do the count, especially when it may be difficult to find and coordinate volunteers safely



# Regions will need to take extra safety precautions due to COVID-19 to reduce the risk of community spread.

Regions need to take many things into consideration when planning local counts that protect enumerators and the target population and reduce the chance of community spread of COVID-19.

- Adequate PPE
- Social distancing
- Hand-washing and regular cleaning
- Outdoor collection when available or well-ventilated indoor spaces

## Planning for the 2021 Unsheltered Count

#### Plan ahead

- Form a subcommittee in your region to figure out your advertising and outreach plan to reach as many individuals experiencing unsheltered homelessness as possible in the run up to 01/27/20.
  - Discuss safety protocols and access to PPE as necessary
- Meet with the region's CE Lead to understand the referral and data collection process. Assign responsibilities to ensure that the right data is collected and the referral process operates smoothly. Don't assume!
- Meet with your region to advertise the plan, provide any necessary resources, and define responsibilities.
- Engage agencies that need to play a role and ensure they participate.



## Planning for the 2021 Unsheltered Count

**Connect with unsheltered clients** 

- Have regular check-ins with the CE Lead and evaluate your progress in getting people living unsheltered on the BNL.
- Provide training and technical assistance to agencies as needed. Check-in with them to ensure they follow the region's plan of action and that referrals to the BNL are happening.
- Plan for the verification follow-up from 01/28 02/09. Define how this will happen and who will be responsible.

- Design the system to collect, analyze and report on data
- Support PIT/HIC Leads and subcommittees to set a plan
- Provide training resources for PIT/HIC Leads and volunteers
- Select a PIT/HIC Lead for the region
- Support PIT/HIC subcommittee as needed
- Provide a venue for discussion, planning, and resources
- Facilitate a plan to connect individuals experiencing unsheltered homelessness to the BNL
- Support the regional PIT/HIC subcommittee to raise awareness, recruit volunteers, outreach agencies, and connect individuals to BNL
- Check-in regularly with the CE Lead
- Support the plan to connect individuals experiencing unsheltered homelessness to the BNL
- Collect data and enter information into the HMIS as needed



## **Collecting Data**

- Conduct interviews with Non-HMIS participating agencies
- Pull HMIS reports and work with HMIS agencies to finalize reports
- Facilitate a plan to connect people experiencing unsheltered homelessness to the BNL including collection of required data
- Outreach providers and check-in regularly to ensure appropriate referrals are made
- Facilitate appropriate training including safety protocols and connection to PPE
- Work with staff or volunteers to conduct surveys of everyone in the program on the night of the count, submit data using the App
- Participate in Housing Inventory interviews with NCCEH

- Work with NCCEH to review HMIS reports
- Verify reports and submit when final


