#### **FY21 CoC Competition**

HUD announced the initial steps of the FY21 CoC competition:

- Registration staff have registered on behalf of the CoC due March 4, 2021
- GIW usually follows 6 weeks after the registration deadline
- NOFA possibly early summer

• Intent to Apply form still open

The Intent to Apply form is mandatory for all agencies applying for new CoC funds and posted to the NCCEH website at: <a href="https://www.ncceh.org/bos/currentcocapplication/">https://www.ncceh.org/bos/currentcocapplication/</a>

- Any agency wanting to apply for a new CoC project in the FY21 competition is required to submit a form.
- Asks for preliminary information about proposed project(s)
- NCCEH staff will review and follow-up with the agency to discuss
  - Any agency that submitted an Intent to Apply form for the FY20 competition does not need to submit another.
  - Staff will schedule follow-up calls later in the year once we have more details.
  - Rolling-basis, non-binding
  - Deadline: 2 weeks after NOFA release

Regional Committee leadership and at-large members can help recruit agencies to apply and direct them to the Intent to Apply form or to <a href="mailto:bos@ncceh.org">bos@ncceh.org</a> with any questions.

The CoC needs agencies with:

- Capacity to operate CoC programs
- Best practice knowledge
- Willingness to serve the most vulnerable people experiencing homelessness

#### Vaccine Roll Out Across the NC BoS CoC

Erika Ferguson, Director of the Office of Healthy Opportunities at NC DHHS, reviewed steps that regional homeless shelter and service agencies can take to help roll out vaccines in their communities.

- Step 1: Meet locally to determine roles and responsibilities of partners.
- Step 2: Contact a local vaccine administrator (e.g., health department, hospital, FQHC, etc.) in your county or region.

- Step 3: Determine vaccine roll-out strategy that works best for your community or organization.
- Step 4: Work with vaccine administrator partner to Submit Vaccine Event Application.
- Step 5: Continue to work with vaccine partner to ensure all people experiencing homelessness have access to vaccinations

All 13 regional leads on the Steering Committee were asked to report what vaccine distribution models were being deployed in their counties comprising the NC BoS CoC. Activity ranged from local health agency partnerships bringing the vaccine to a program site or bringing people to vaccination sites. There were some counties in which no activity was reported.

# **FY18 SSO-Coordinated Entry Grant Report**

NCCEH receives a CoC grant to support Coordinated Entry. The FY18 SSO-CE grant had operating dates of September 1, 2019 through November 30, 2020. Initial awards were made to the following agencies:

• Region 2: Thrive

Region 3: Greater Hickory Cooperative Christian Ministry

• Region 5: Community Link

Region 10: Hope Station

Regions 11 and 13: Trillium

Region 12: Pitt County Planning

NCCEH requested an extension from HUD for FY18 SSO-CE funds due to challenges from the COVID-19 pandemic. The initial plan to contract with United Way of NC/NC 2-1-1 to provide front door access changed. To ensure NCCEH maximized spending, the agency provided additional subgrants to the following new agencies on July 1, 2020:

Region 1: HERE in Jackson County

Region 4: Diakonos

Region 6: Family Abuse Services

Region 7: Johnston-Lee-Harnett Community Action

Accomplishments in FY2018: increases in CE access by 58%; CE screening or assessment by 54%; and CE referrals to Rapid Rehousing by 118%. There were challenges with the Coronavirus federal funding, starting with the short turnaround of a 2020 grant-end date, especially for newly funded agencies. There were challenges, too, with SSO-CE staff shifting focus to CRF and ESG-CV work and United Way of NC/NC 2-1-1 as the access point through Back@Home. NCCEH and subrecipients spent approximately 76% of FY18 SSO-CE grant. Spending for FY19 SSO-CE grant is set to increase in second year for all.

For FY2019, NCCEH provided SSO-CE subgrants to the same 10 agencies across 11 regions. SSO-CE funded-agencies set goals for FY19 to increase CE participation for non-HUD-funded agencies and increase street outreach activities. There are plans to also increase CE access for people living unsheltered while decreasing data gaps between front door providers and the CE project. NCCEH staff has started extra support for regions without SSO-CE grants.
