O Information is being gathered about what each region is doing or planning to do as it pertains to vaccine distribution. Teresa shared that Erica Ferguson would be a good point of contact. Updates on what is being done in our region:

Davidson-Mostly staff is vaccinated. They do have a working relationship with their health department to create a plan for vaccines.

Rowan- They are encouraging guest to get vaccinated and has had one distribution on site thus far for individuals to receive the vaccination.

Stanly- The navigator is currently going through caseloads and assisting with clients to get vaccines scheduled. Staff vaccines are coming soon.

Community Link- Onsite vaccination clinic is set for Friday April 16th for employees and family members. It will potentially be opened to the public if they do not have enough participation. Continuing virtual work and working on a plan to discuss what return to in person work will look like.

Union- Has a relationship with local health department and was able to facilitate an onsite vaccination distribution for roughly 30 clients and staff.

Salisbury VA- The vaccine is now available to veterans as well as their spouses and or care takers.

It must include households and individuals that are included in the Coordinated Entry process or those that are referred to housing through Coordinated Entry in the past year.

RRH and PSH program purpose and goals

Permanent Supportive Housing- Jill Valente Program Manager shared that there are potential openings in the near future for PSH. Jill is hoping to see some movement within the PSH process while being mindful of the budget as we proceed. Permanent Supportive Housing is designed for those coming off the streets and those that need extra support through the housing process. PSH includes intensive case management. Jill shared that if households are struggling in RRH there may be potential to have a conversation of moving households from RRH to PSH if that would be helpful. Rapid Re-Housing- Tamatha Hall Program Manager shared that RRH is designed to help people exit homelessness rapidly and sustain them in housing efficiently. The piedmont region currently has three workers. While in the RRH program clients are expected to work on goals to try and achieve self-sufficiency. Working through stagnation is a part of this transitional period. Clients are provided with resources and programs that may be of benefit to them after the duration of support through RRH has ended. By-Name List breakdown and information to look for

- Teresa shared the By-Name list data page that is pulled. During the meeting Teresa went over the tabs that can be found as well as the prominent tabs to note. The By-Name list will continue to be used going forward to navigate Case Conferencing calls. The By-Name list allows us to note households being serviced, who is providing the service and where the funding is coming from.
- Entered in CE Project- Please ensure that you are entering individuals to the CE project.
- Length of Stay in Shelter (Cumulative Vs. Not)- Length of stay is crucial in our data reporting as it allows us to ensure needs are being addressed accordingly.
