Approval of Consent Agenda

- The consent agenda was voted on at the beginning of the meeting. Without changes or objection, the consent agenda was approved by common consent.

ESG Annual Allocation Recommendation

Laurel McNamee walked the Steering Committee through the process followed by the Project Review Committee to consider the 34 renewal applications and 9 new applications for CY2022 ESG funding. NCCEH staff reviewed all the renewal applications, one renewal application was flagged for further PRC review. Each of the new project applications were reviewed two times by 1-2 staff person and 1-2 PRC members.

The PRC used the following criteria as precedent to make consistent decisions for the proposed slate of grantees in each region:

- Allocate extra available funding to RRH financial assistance
 - If one RRH program, give all to RRH applicant.
 - If multiple RRH programs, look at Review Tool performance criteria to determine most effective applicant to allocate funding.
- Attempt to fund good, new Project Applications that can meet Written Standards by 01/01/22
- Evaluate staff and financial capacity to spend requested funding
- Review funding requests in 2022 versus awarded funding amounts in 2021

Several clarifying questions were raised and answered which Brian provided both verbal and written explanations. The presented slate of CY2022 applicants can be seen in the table below:

Racial Equity Assessment

Andrea Carey provided an update on the Racial Equity Assessment. The CoC expanded the scope of its analysis this year to better understand racial disparities. Through a collaboration of NCCEH staff and the RE subcommittee, the 2021 RE Assessment was presented.

- Data Center and CoC staff pulled and evaluated data in four ways:
 - HUD Continuum of Care Assessment Tool
 - National Alliance to End Homelessness' Racial Equity Tool
 - HUD Stella Performance Module
 - NC BoS CoC coordinated entry data
