



**Scoring Process/Project Applications** 

#### The CoC Consolidated Application has 3 parts.

CoC Application	Captures CoC-wide information				
	NCCEH, as Collaborative Applicant, writes this application on the CoC's behalf				
	Input from agencies, Regional Committees, Steering Committee, and stakeholders necessary to give full scope of the CoC's work				
Project Applications	New projects				
	Renewal projects				
	DV Bonus project				
	CoC Planning grant				
Project Priority Ranking List	Ranked list of each project				
	Recommended by the Project Review Committee				
	Approved by the Steering Committee				



## **Project Review Committee plays a crucial role in the application process.**

- Composed of one representative from each Regional Committee\* and interested at-large Steering Committee members (not grantees or applicants).
- Scores new and renewal project applications using approved scorecards.
- Recommends ranked list of new and renewal project applications for CoC Collaborative Application to the Steering Committee.



## Scoring and ranking projects allows the CoC to prioritize funding for the best projects.

Scoring and ranking:

- Allows the CoC to prioritize funding based on HUD and CoC priorities and needs
- Ensures the CoC prioritizes funding for projects that have high performance and manage funds well
- Required by HUD



## NC BoS CoC has almost \$12 million in homeless funding at stake in the FY21 CoC competition.

#### **Project ranking was informed by the CoC's Funding Priorities and the scorecard.**

#### NC BoS CoC Funding Priorities

Guidance from the Continuum of Care on its priorities for funding. This includes priorities for funding specific project types and regional need.

#### Scorecard

*Thresholds:* Essential components that must be met in order to be funded.

Standards: High priorities for projects to ideally meet that indicate programmatic success.

*Minimums:* Meeting section minimums indicates well-rounded projects and that essential components are not missing that could affect performance.

Points: Used to incentivize practices and to pull higher performing projects up in the ranking list.



## PRC and NCCEH staff used approved scorecards to review applications.

Two Types of Scoring

Combined Scoring section of each application scored by:

- One member of the PRC
- One member of NCCEH staff
- Combined Scoring section scores are averaged.

Staff Scoring section scored by NCCEH staff

Combined Scoring + Staff Scoring = Total Score

Renewal Project Review/Ranking

## **Renewal project summary**

28 renewal projects turned in applications.

- (1) HMIS project (not scored)
- (1) SSO-Coordinated Entry project (not scored)
- (22) Permanent Supportive Housing projects
- (4) Rapid Rehousing projects

#### Scored renewal projects:

- (0) applications with threshold issues
- Family Abuse Services did not submit their RRH application for renewal. \$59,860 will be reallocated to a New Project.



# The PRC used precedent and reason to rank renewal applications.

The PRC included a late renewal application in the ranking list based on application quality and did not penalize for missing the standard.

• Thrive had significant, documented issues with esnaps that prohibited it from submitting the application on time.

The PRC did not reallocate any projects due to performance or spending this year.

- No significant spending issues without sound explanation
- Performance measured over 2020 no clear performance issues in pandemic year
- Family Abuse Services' RRH project reallocated because it did not apply \$59,860
- All renewal applications ranked in Tier 1



## The PRC used precedent and reason to rank renewal applications.

The PRC held with precedent and ranked the HMIS and CE applications at the top of the prioritization ranking list.

- Protects required infrastructure
- Funding Priorities document prioritizes infrastructure grants



## The PRC held with precedent, using Housing First and program design standards to rank renewals.

Housing First Standard: PRC recommend pulling down in the rankings

Standards Missed	Number of Renewals			
Housing First	0 agencies, 0 projects			

#### Key Elements and Benchmarks: PRC recommend pulling down in rankings

Standards Missed	Number of Renewals		
PSH Key Elements (missed 1 element)	3 agencies, 5 projects		
RRH Benchmarks (missed 1 benchmark)	1 agency, 1 project		



# The PRC used two other standards to order renewal applications in the ranking list.

Two standards used to pull up project applications that met key standards the CoC has emphasized over the last 2 years.

Anti-Discrimination Policy standard

- Diversity, equity, and inclusion has become a high priority for the CoC since the FY19 competition.
- Agencies have been required to have the CoC's Anti-Discrimination policy in their programmatic policies and procedures for 4 years.

#### Coordinated Entry standard

- HUD requirement that funded agencies take <u>all</u> referrals from the CE system.
- Agencies that participate fully have been pulled up in the ranking list.



New Project Review/Ranking

## New project summary

8 new projects turned in applications.

- (3) Permanent Supportive Housing projects
- (4) Rapid Rehousing projects
- (1) DV Bonus projects
  - (1) Rapid Rehousing

Some new projects had issues:

- (1) new RRH project had initial threshold issues
  - Staff notified Southeastern Family Violence Center they could not proceed in the competition
- (1) new RRH project submitted in the first submission but not the second not scored
- (2) new RRH projects were submitted late
  - Thrive RRH all non-esnaps documents on-time
  - Greene Lampe RRH esnaps documents turned in on-time; some non-esnaps documents late
- (1) new PSH missed the Housing First threshold
  - Diakonos PSH pulled from ranking list options

# The PRC recommends including the DV Bonus project at the bottom of the ranking list.

PRC recommends the DV Bonus new application be listed at the bottom of the ranked list.

- Quality application with far ranging impacts for DV survivors
- Only application to take advantage of DV Bonus
- Size could eliminate other projects if higher in the ranking list



# The PRC considered weighed different options to rank new Project Applications.

The CoC received 7 new project applications requesting \$2,068,222.

Type of funding	Amount available				
Reallocation	\$ 59,860				
CoC Bonus	\$ 699,861				
Total	\$ 759,721				

The PRC considered options such as:

- New project funding priorities
- Program design standards
- Quality of applications

The PRC decided to use a combination of these to ensure the highest quality/highest priority projects were included.



# The PRC used weighting of funding priorities and quality of applications to choose new projects.

The PRC weighted the regional project prioritization

- Priority 1 projects received 40 bonus points
- Priority 2 projects received 20 bonus points
- Priority 3 project received 0 bonus points

After weighting, new projects were ranked in point order to emphasize quality of applications.

This process yielded inclusion of three new projects in the ranking list.

- Thrive RRH: Priority 2 project with 108.5 points
- Greenville Housing Authority PSH: Priority 3 project with 105.5 points
- Brick Capital Community Development PSH: Priority 1 project with 81.5 points

• Weight priorities and rank in point order: 40 points for Priority 1; 20 points for Priority 2

### **Next steps: Notification and Appeal Process**

Staff will notify applicants regarding decisions by COB October 14<sup>th</sup>.

- Staff will send scorecards to applicants and offer follow-up calls after the competition.
- Applicants whose projects were not included in the final Prioritization Ranking List can appeal decisions.

#### **Appeals Process**

- Appeal documentation due to NCCEH by Wednesday, October 20 at 12 PM
- If appeals are submitted, the PRC will meet on Thursday, October 21 to consider information.
- If the PRC recommends overturning a decision, the Steering Committee will meet on Friday, October 22 at 2:30 PM.
