Macon New Beginnings - continued issues with landlord availability and housing; issue w people destroying rentals and pulling housing off of markets; 6 months wait;

RoMacon - 8 women & 4 kids, large family coming in today; new case manager - Veronica

Toby - Cherokee empty; 7 adults in the past few weeks; **interested in programming on working with landlords**

Destri - 3 in RRH program, 2 looking; emergency shelter beginning Nov.

Sarah - 1 client in shelter; DVPO heavy month, difficulty with availability;

Bob - continued difficulty w landlords & availability/price Smoky Mountain News - Housing Trust Fund,

Dan, Four Square - 450 graham, cherokee, swain, clay; anticipates an increase in homelessness due to payment standard being raised and tenants not being able to afford; also substandard conditions; HQS (home quality standards); takes effect October 1; primarily elderly and disabled people being affected;

Pat - only 14 residents, 7 men 6 women 1 child; 19 beds open
