# • Rental Assistance Referral Training - HERE in Jackson County

- Rapid Rehousing (RRH) is
  - Funded through Housing & Urban Development (HUD) and is channeled through the North Carolina Emergency Solutions Grant Office (NCESG) at the Department of Health & Human Services (DHHS). This program is intended for those living literally homeless (having a nighttime residence in a place not meant for human habitation, living in a shelter, or fleeing domestic violence). This program is available to all eight western counties in Balance of State Region 1 (WNC Homeless Coalition).
  - Initial assistance approval amounts range from deposits to 3 months rental assistance. Funds are available for security deposits, utility deposits, arrears, and rental assistance.
  - It is a government grant so the paperwork is lengthy. Referral Packets should include the entire packet including all ESG documents and a Third Party Verification of Homelessness from the referring agency.
- HERE's Housing Acquisition & Stabilization Program (HASP) is a pilot homeless prevention program that seeks to help households that do not qualify under HUD's definition of literal homelessness in obtaining permanent housing and avoiding entry into literal homelessness. As a pilot program, HERE welcomes feedback from participants to strengthen the program and resolve any concerns.
  - It is a one time assistance for up to \$750. As a grant funded program, its area of service is limited to Cherokee, Clay, Graham, Jackson, Macon, and Swain.
  - Referral packets should include the HERE referral form and checklist, W9, invoice, and a copy of the lease.
- Referring agencies are expected to continue housing case management with clients entered into the program unless otherwise communicated with HERE.
- All clients, referrals, and units should be accepted by HERE before a lease is signed or any funds promised. HERE cannot reimburse <u>any</u> clients. Any agencies seeking reimbursement for client assistance should seek prior approval with HERE before distributing funds.
