STANDING AGENDA ITEMS

- Balance of State Steering Committee Update
 - Steering Committee updates and documents can be found at <u>https://www.ncceh.org/bosminutes/</u>
 - Derek provided updates based on Steering Committee info
- Coordinated Entry Update
 - Robert facilitated discussion about EHV's that could be ported to Region 1
 - EHV: Covid funding resource made available to state and Region 1 can have vouchers ported from Commission of Indian Affairs (414 vouchers)
 - Like Section 8 housing choice vouchers
 - Permanent voucher
 - Difference: go up to 120% of FMR, unique and valuable resource
 - Reviewed 3 priority groups
 - PSH moving on
 - PSH eligible but lack documentation
 - Families or individuals on CE waitpool who need long term rental assistance (category that could assist large portion of Region 1 homeless)

- Questions about EHV and paperwork/process
 - Through PHA (Mountain Projects and Four Square on call)
 - Four Square: Clay Graham Cherokee Swain
 - Four Square detailed various options
 - Difficulties with general lack of capacity
 - Current PHA voucher wait is 2-3 years
 - Monica: explained additional EHV info and process to present during RAMM to determine best fit for household
 - Concerns about rental prices far exceeding FMR due to housing shortages (EHV can accept 120% of FMR)
 - Targeted Key program is going to start working with EHV households
 - Details currently for Targeted Key in relation to EHV are TBD
- Explained purpose for CE and intent of CE along with brief description
- Detailed case staffings as key component and what staffings should consist of
- CE: remaining low barrier; if approved for RRH and/or PSH can be staffed and accepted during RAMM but before spending any funds, they would need to be added to CE
- Rapid Rehousing Update
 - Robert: plenty of funds remaining for RRH due to Back @ Home
 - Over 43K remaining funds for RRH
 - Anyone approved through end of year can access 2022 funds
 - Approved 27 people but only spent funds on 4 of those approved households
- Back@Home Update
 - Robert: brief description of program
 - Ends June 2022
 - Robust RRH and homelessness prevention program
 - Paying rent and deposits for large number of households, covering all of WNC counties
 - Specific numbers: Back @ Home started Dec-June
 - 17 households housed
 - 32 individuals housed
 - Since July to present
 - \circ 30 households housed
 - Previously ceased referrals due to back log but 211 is now open again for referrals/referral process
 - 20 min call, screening process
 - 211 screens and then HERE picks up case at that point
 - 1 dedicated case manager resigned recently, so currently only 1 case manager and unlikely to fill position due to program ending June 2022 and anticipated learning curve for this role/position
- Permanent Supportive Housing Update
 - Derek relayed update about grant numbers for PSH and spending as of just prior to

Thanksgiving

- Derek relayed that PSH able to accept 2 more households today during RAMM if applicable and entered to CE process
- Agency Report Outs
 - REACH of Macon: Veronica stated they are at capacity currently, requested contact if someone aware of vacancies
 - Destri Leger: PIT Count Lead: reviewed changes to PIT
 - Changes: no unsheltered count this year that is not HMIS related,
 - Sheltered count has remained same process for those in shelters
 - HMIS
 - CE or another front door project to be counted for PIT
 - Household must have some interaction with HMIS user to be counted
 - PIT app used in past; this year those individuals need either VISPDAT to be added to CE system or for those not interested in CE process but want to be included in count then front door project would add their data which would most likely come from street outreach work
 - Trying to determine logistics for capturing this data and having discussions with state about having new project pertaining to street outreach
 - Positives, once added to CE or front door then they are already included in system and could be considered for assistance
 - Working through learning curve to improve efficiency with process changes
 - if working with unsheltered population then asked to connect with Destri and Destri provided her contact info to support with connection for future street outreach
