 - FY 22 CoC Competition
 - NOFO released 8/1/22 and posted on website
 - Final app due to HUD by 9/30/22
 - Short time frame (under 2 months)
 - Intent to Apply for new applicants was due 8/10/22 at 6pm
 - Instructions released 8/2/22
 - Timeline
 - 1st submission due 8/12/22 by 6pm
 - 2nd submission due 8/19/22 by 6pm
 - Post the CoC app 9/23/22

- Submit CoC app 9/27/22
- CoC app deadline 9/30/22 by 8pm
- Special NOFO Competition for unsheltered and rural homeless
 - Unsheltered set aside < \$15 million
 - Rural set aside > \$10 million
 - 3-year grant term
 - Final app due 10/20/22
 - Require plan to serve the unsheltered and/or rural homeless
 - Requires dedicated units specific to the Special NOFO
 - Medical and Behavioral Health agreements need to be in place
 - Concerns:
 - Building capacity
 - Impact to current systems and providers and the potential corresponding overload
 - o 3 funding competitions transpiring simultaneously
 - Reviewed Oversight Agency Role
 - Administer Special NOFO grant funds
 - Contract with central agency as a Financial Assistance Coordinator and with regional service providers
 - Ensure compliance and adherence to best practices
 - Reviewed Financial Assistance Coordinator
 - Details for this role are listed in the Special NOFO section below in the other agenda items section
 - Reviewed Regional Service Providers role
 - Provide CM and street outreach
 - Would not play a role in paying for units
 - Support unsheltered with access to CE
 - Work with Financial Assistance Coordinator to assist households procure units
 - Provide housing stabilization and tenancy support once housed
 - Case Management is fully funded in this model
 - BoS Steering Committee voted to approve "plan concept" on 8/2/22
 - Document is still in draft form
 - Plan approval was needed to release instructions and open the competition

 - O Cleaning up by name list, reaching out to agencies for clean up
 - Email from Keri and Mandy Haywood Pathways to Greta plan to have updated by name list for shelter 8/17
 - Meeting w/ Nicole and Ashley BoS Staff regarding CE cleanup
- Rapid Rehousing Update (Gretta Worley)
 - o 12 households housed
- Back@Home Update (Gretta Worley)
 - o 59 households housed
 - o Ends 9/30/22
 - O Met w/Katy, do not foresee housing late in month (Sept) as all must be turned in 9/30
 - O Can assist with utility bills for October if paid in September
 - o If emergency need, will do best can do to assist
- Permanent Supportive Housing Update (Derek Lancour)
 - 40 households served (below grant minimum but awaiting several referrals for previously approved PSH households)
 - o 33 currently housed
 - o 7 looking for housing (Haywood and Jackson primarily but also 1 in Graham and Clay)
 - 70 persons served in total,
 - 56 adults and 14 children
 - Spending (through 2 months): current spending is at just under 12% and minimum goal would be 15%
 - Annual Performance Report (APR): submitted to HUD on 7/29/22
 - Lori Watts working with on Vaya's PSH grant renewal application working to meet 1st deadline 8/12 and 2nd deadline on 8/19
 - O Monica Frizzell inquired if Region 1 approval/blessing needed for Vaya to pursue grant renewal. Monica made a motion to support Vaya's renewal application in the CoC Grant competition. Kenett Melgar seconded the motion. No further discussion, all in favor, no one was opposed, the motion carries
- Agency Report Outs
 - Four Square Community Action Daniel Ferreira reports being able to offer EHV's from CE for first time
 - O Restoration House Parker Chatham, <u>Restorationhousewnc31@gmail.com</u>, new director of Restoration House in Swain, has been a cold winter seasonal shelter but beginning in November 2022 it will become year-round and will not close after winter. It can offer shelter during day as well. 7 beds currently in a donated house, other counties can be served but priority will be given to Swain residents first, seeking county funding. Men only currently; working with NC Care 360
 - O Disability Rights NC Kirby Morrow looking for resource information for persons; Lori

Watts will share some information for Vaya's 31 counties with Kirby (delayed by grant deadlines and other challenges but will still get information out)

- Oversight Agency would contract with CoC Financial Assistance Coordinator
 - Rental assistance and landlord recruitment
- Oversight Agency would also contract with local providers
 - Oversight Agency responsible for:
 - o Administering grant funds
 - Reporting
 - o Drawdowns from HUD reimbursement
 - Project budget line items
 - Make decisions
 - Ensure match criteria is met
 - Financial Assistance Coordinator
 - o Contract with Oversight Agency to locate and pay for units
 - Landlord engagement
 - Work with local providers to ensure entities follow the prioritization guidelines
 - Quick and regular payments to secure units
 - Deposits
 - Rent
 - Utilities
 - Other eligible expenses
 - Regional Service providers
 - Contract with Oversight Agency
 - o Provide street outreach and engage folks
 - Connect to shelter
 - o Provide access to CE for unsheltered along with Case Management
 - Work with Financial Assistance Coordinator to procure units
 - Provide housing stabilization and tenancy supports
 - Regional Service providers would follow
 - Harm Reduction
 - Housing First
 - o Trauma Informed Care
- Currently only accepting apps for Oversight Agency
- Project types
 - PSH
 - RRH
 - Street Outreach SSO
 - SSO- other
 - CoC planning (collaborative applicants only which would be NCCEH)
- Unsheltered set aside
 - Serve categories 1 and 4 (79 Counties)
 - Literally homeless or fleeing DV
- Rural set aside
 - Same as Unsheltered but serve the 55 rural counties
 - Additional activities
 - o Up to 6 months of rent
 - o Pay utilities after 2 months of non-payment
 - Short term shelter (hotel and motel stays)
 - Repair/rehab units
 - Capacity building
 - o Emergency food and clothing assistance
