


Racial Equity Subcommittee Meeting NC Balance of State CoC January 18, 2023 at 11:30 AM






#### Camera


# What is the NC BoS CoC Racial Equity Subcommittee?

## The Steering Committee is the governing body for the CoC

- Guided by the Governance Charter, the Steering Committee is a representative body of regional leaders and state-wide at-large members.
- The Steering Committee has several sub-committees that operate at the CoC level including Racial Equity Subcommittee, Funding and Performance Subcommittee, Coordinated Entry Council, and Lived Expertise Advisory Council





## NCCEH serves as the NC BoS CoC Collaborative Applicant and HMIS Lead.

#### The North Carolina Coalition to End Homelessness:

- Staffs the CoC
- Facilitates the CoC competition each year, writes the CoC-wide application, and submits to HUD
- Ensures the CoC meets HUD requirements
- Provides training and technical assistance
  - Conducts performance improvement with ESG and CoC grantees
  - Teaches best practices
    - Harm Reduction
    - Housing First
    - Low-barrier, Housing-focused shelter
    - Case Management
  - Supports HMIS end users
- Serves as grantee for HMIS and CE project



Current Coordinated Entry Assessment is racially biased






#### **CE Equity Initiative**

- Planning for the new assessment
  - Goal: By December 2023, North Carolina Balance of State aims to proportionally increase the scores of Black/African Americans assessed through a revised assessment to 43%
  - Categories of questions: Safety Risk, Housing and Homeless History, Health and Wellness, Family unit
    - Focusing on challenges to housing to prioritize
- Bringing It Home Conference Proposal submitted: "Centering Equity to Redesign Coordinated Entry Assessment and Prioritization"



#### **CE Equity Initiative**



- Timeline
  - Draft Phase (October December 2022)
  - Revision with Stakeholders Phase (January March 2023)
  - Pilot Phase (April June 2023)
  - Analysis & Revision with Community Phase (July August 2023)
  - Training Phase (September October 2023)
  - Launch Phase (November 2023 January 2024)


#### **RE Assessment Workgroup**



## Urgent opportunity for impact: Updates to competition scorecards



#### New schedule requires updates by 2/28
