



Significant Change Request: Pitt County Planning for CoC Rapid Rehousing Program

Pitt County Planning operates a CoC-funded rapid rehousing project. They have requested to decrease the total number of units served from 24 to 6. This change has been discussed with CoC and HUD Field Office staff. Since the award of this project, Pitt County has changed the scope of the project. Originally, this project intended on braiding the CoC-funded project with Pitt County's ESG-funded project. Due to increased funds to the ESG-funded project, Pitt County no longer needs to dually enroll clients in both funded projects. The reduction of units reflects the number of units funded with financial assistance through the CoC-funded project.

Lived Expertise Advisory Council

March 10, 2023, Minutes

Comments from NCCEH Executive Director Ryan Fehrman: Ryan provided an overview of his role and NCCEH strategic planning, board recruitment, and advocacy. Ryan asked for members to participate in an advocacy day. Ryan took questions and encouraged members to provide further feedback by contacting Laurel McNamee.

Kenneth Stewart joined the meeting from the Salvation Army of Greater Hickory. His supervisory mistakenly told him to join the group not knowing where the LEAC is in its recruitment strategy. Kenneth was welcomed to stay for the meeting and learn about the work of the LEAC.

Client Bill of Rights: Rachelle and Jeff updated the group on the SC presentation of the Client Bill of Rights, including that the steering committee members feedback and request for more time. The LEAC requested that any feedback sent to NCCEH be forwarded to them and that they have time to prepare before the next Steering Committee meeting. Ad-hoc LEAC meeting was scheduled for March 27, at 1:00pm to discuss any feedback received.

Bringing It Home Conference: The LEAC discussed their upcoming presentation at the Bringing It Home Conference on May, 2. All agreed to make the Client Bill of Rights a focal point and include some brief sharing of personal experience.

Jeff urged the group to avoid pointing to "more affordable housing is the answer". Focus on immediate actions that agencies can take: look at your boards, involve PLE in decision making.

Framing for BIH Conference presentation will take use the following framing:

Past, present, and future:

Past: personal experience for context, formation of the LEAC and its vision

Present: experience of being on the LEAC. Current work.

Future: implementation of the client bill of rights. Actions that audience members can take. Reemphasize that PLE should be at ALL levels of decision-making. It's not that hard!

FY20 SSO-CE Grant Report

Ashley Von Hatten reported on the FY20 SSO-CE grant (12/1/2021 - 11/30/2022).

Accomplishments included NCCEH and subrecipients spending down 100% of the grant, BoS and agency-level goals added to FY20 grant agreements, expanded street outreach coverage, and participation in HUD's CE Equity Initiative. The FY20 Annual Performance Report (APR) showed an increase from 2248 persons served in FY19 to 6806 in FY20, with an overall low error rate. The APR reflected an increase utilization of CE Access Events and CE Referral Events.

Special NOFO Discussion

Allie Card provided an update of NC BoS CoC's Special NOFO awards, with approximately \$7 million awarded for rural projects and approximately \$14 million for unsheltered projects. NC Office of Recovery and Resiliency (NCORR) applied for the Special NOFO funds and will publish an RFP when the awards are available.

Allie facilitated a discussion around the work of connecting unsheltered households to Emergency Housing Vouchers, to provide feedback to Special NOFO workgroups.

- Challenges of connecting person living unsheltered to EHVs included:
 - Barriers with Smartsheet and deadlines
 - Barriers with transportation
 - Lack of case management and housing navigation
 - Shortage of affordable housing
 - Barriers with background checks
 - Housing search falling onto the client and/or Front Door provider
 - Struggle to understand lease

Useful process and/or services of connecting persons living unsheltered to EHVs included:

- Consistent and ongoing case management
- Weekly meetings with providers and partners
- Discussion at case conferencing to connect clients with open resources
- Intensive case management
- Dedicated staff person for housing navigation
- Active list of available housing
- Specific resources and funding for unsheltered teams and/or Street Outreach staff

Core Team Update

Ashley gave an overview of the Core Team and their work to date. NC BoS was selected in 2021 to take part in HUD's Coordinated Entry Equity Initiative. The initiative's goal is to support communities in improving housing outcomes and the human experience for Black, Brown, Indigenous and all people of color. From October 2021 – October 2022 NC BoS met bi-weekly with HUD coaches and completed the following:

• Developed an inclusive Core Team with a diverse range of local stakeholders to ensure the process is rooted in equity-based decision making.

• Developed an overall results statement: All Black/African Americans experiencing homelessness in North Carolina Balance of State are swiftly assessed and connected to safe, stable, and suitable permanent housing and housing resources.

• Developed a targeted goal statement: By December 2023, North Carolina Balance of State aims to proportionally increase the high scores of Black/African Americans assessed through a revised assessment to 43%.

HUD CE Equity Initiative ended October 2022, but the Core Team is still working towards the end goals of creating an equitable assessment tool. The Core Team did not want to re-create or update the current assessment tool, did not want to re-traumatize people who are being assessed, and wanted to only ask questions that held value for HUD-funded permanent housing.

Core Team next steps include (with the CEC and Racial Equity Subcommittee simultaneously voting on the final assessment):

- Revision with Stakeholders (January March 2023)
- Pilot Phase (April June 2023)
- Analysis and Revision with Community Phase (July August 2023)
- Training Phase (September October 2023)
- Launch Phase (November 2023 January 2024)

2023 CE Evaluation Materials and Process

Ashley provided an overview of the 2022 CE Evaluation, which showed the CoC could make improvements to low-barrier emergency shelters, the assessment tool, warm hand offs from Front Door providers to Permanent Housing providers, funding to support households at imminent risk of homelessness, and increases in affordable housing.

Noting the work of the Core Team and the required update to the 2024 CE Evaluation materials and process, the CEC determined to use the same evaluation process and materials from 2022 in 2023. NCCEH staff will review the materials and ensure the language is accessible to all clients, as requested by the CEC. The dates proposed for the 2023 CE Evaluation for Permanent Housing surveys are April 3, 2023 through May 26, 2023. The dates proposed for Shelter and/or Street Outreach surveys are May 15, 2023 through May 26, 2023. Maxcine Barnes made a motion to approve the 2023 CE Evaluation distribution, collection, survey content, and timeframe with a second by Lynne James.

Unsheltered PIT

Ashley provided an update on Unsheltered PIT data, as of March 9, 2023. 1329 persons have been identified as living unsheltered on the night of 1/25/2023, with five regions confirming their final numbers. Unsheltered Access Coordinators and CE Leadership are asked to be responsive to emails, confirm data in their region, confirm all available data in entered, and resolve any data conflicts. Unsheltered Access Coordinator terms are May through April and regions should be having active conversations around identifying the most appropriate person for this role. The goal of UACs is to ensure all people living unsheltered are connected to services, build trusting relationships, collect contact information for follow-up, assess and refer to the by-name list, and refer to emergency shelter when possible.
