5. Community Resource & Agency Updates

- A. DSS-Pasquotank County-Energy Program starts December 1, 2023 -those in need of assistance may call or go to the agency to complete an application for assistance.
- B. Coordinated Entry- working toward a separate CE for Veterans. Michelle will reach out to those who these effects. Discussed the new smartsheet that should be completed along with the VI-SPDAT
- C. School System- 79 students served so far this year who need assistance only in the 11th day of school. Last year they served 144 and 112 students the year before. This includes students in school, young siblings not in school and other siblings not in school (working on GED etc.). Continuing to partner with other agencies to help with families in need of services.
- D. County- no updates or announcements
- E. Spring Life- The agency is seeing an increase in people presenting who need state funding for services and in need of medication refills. This is problematic because the individuals can not readily access state funded services due to the approval process.
- F. Dungarvin- no updates or announcements

6. Housing Program Updates

- A. River City Community Development- not providing any ESG shelter at this time, will start back in October after new funding. Housed three families and have a waitlist of over 30 people. Located a new building. Will start as temporary shelter then will become a homeless shelter for the city. Will serve as a congregate shelter. The building does need some renovations. This will allow them to move from the hotel method of shelter unless there is an emergent need to use a hotel. The goal is to have the facility open this quarter- before it gets cold. Can support twenty to twenty-five people. The idea is to house a family upstairs. The address of the building is 318 S Hughes Blvd Elizabeth City NC
- B. EIC- not present- no update
- C. Trillium Health Resources- CoC grant renewal application submitted for Rapid Rehousing and Permanent supportive housing.
