

2011 PPRN

- Renewals

PPRN available for New Projects

- SHP project requests must fit within available PPRN.
- S+C project requests can be for more than RC's available PPRN
- Renewals do not HAVE to be renewed. If your RC is considering NOT renewing a project, contact bos@ncceh.org to schedule a consultation.
