## **NCCEH Update**

Dear friends,

It certainly hasn't been a sleepy winter in North Carolina. This year's weather has seemed to be a good fit for our pace of work. We haven't found anyone that has been able to go into a short hibernation mode - communities are moving full steam ahead with plans to end homelessness.

Changes to HUD's ESG Program, now the Emergency Solutions Grants Program, are the first big rule changes our communities have seen because of the HEARTH Act. The program's change creates new opportunities for communities to work as a system and invest in solutions such as rapid rehousing that end homelessness. All of this opportunity comes with challenges.

For a long time, I felt like we were pushing a large boulder up a hill. There were many forces working against us in the fight to end homelessness. Now, it feels as though we've made it to the top of the mountain. We can see how far we've come and remember the lessons we learned along the way. We can see what's on the horizon and the landscape around us. We can see the path down and the obstacles in front of us.

Our task now is getting the boulder of change down the hill without creating a rock slide beyond our control. It will take us all working together to create a new system that takes advantage these awesome opportunities before us.

Preliminary reports are showing that statewide homeless numbers stayed relatively steady over the past years. Most communities have slight increases or decreases. We're continuing to see communities with significant decreases in chronic homelessness.

We know we're headed in the right direction. We know there's so much change happening now that we have to stay on top of it and ahead of the curve. I hope you'll join us for our March Tuesdays at Two to learn more about the ways the system is beginning to change.
