BoS CoC Regional Committee ESG Conditional Awards Announced

- The State announced the ESG conditional awardees on 8.30.12
- Total BoS CoC conditional award amount = \$2,272,566
- Total BoS CoC extra funding award amount = \$442,110
- Every Regional Committee applied for ESG funding except Harnett and Person Regional Committees
- 15 BoS counties did not apply for ESG funding:
 - Northampton, Bertie, Martin, Washington, Dare, Tyrell, Hyde, Pamlico, Jones, Harnett, Caswell, Rutherford, Polk, Madison, Person

BoS CoC Regional Committee ESG Conditional Awards Announced

- Two regions applied for funding that are not official BoS CoC Regional Committees:
 - Carteret and Craven
- Five Regional Committees combined forces for the ESG application:
 - Downeast, Southeast, Twin County joined together in one application
 - Surry joined Iredell/Yadkin RC and added Stokes and Davie Counties
- Every Regional Committee that requested funding received conditional awards
 - Some RCs only received a partial award

BoS CoC Data Quality Project

- NCCEH staff has worked with CHIN staff on a plan to improve the data quality of the BoS CoC
 - Every other month, NCCEH and CHIN are reaching out to BoS CoC agencies with low DQ scores (cc'ing Regional Leads)
 - CHIN runs a DQ Follow-Up Report for the agency and then works with them to raise their DQ score by fixing errors
- CHIN Data Quality Subcommittee met Tuesday, August 28
 - 14 in attendance including NCCEH and CHIN staff
 - NCCEH staff reviewed the BoS structure and organization, importance of data quality, how CHIN data is used
 - CHIN staff reviewed the Data Quality Follow-Up Report and also reviewed the overall BoS CoC DQ report that is accessible by end-users

BoS CoC Data Quality Project

- BoS CoC staff is now in discussion w/ CHIN regarding how to involve the Regional Leads in helping to improve DQ in their regions
- CHIN staff will be on every DQ subcommittee call

BoS Grantee QPR Issues

- Since the new QPR was released and included an easier due date tracking mechanism for grantees, NCCEH stopped sending QPR reminders
- Some BoS CoC grantees are still not turning in their QPRs, so NCCEH will contact them in the coming week regarding setting up a phone conference time to discuss their grants and the QPR
- QPRs are important!
 - They help the BoS CoC to maintain our competitiveness in the annual CoC application
 - Not completing QPRs can put your CoC funding at risk and also may put the BoS CoC funding at risk, in general
 - What one agency does affects us all
 - QPRs will be updated to reflect HEARTH performance measures once we have them and can report on them using CHIN

BoS Grantee QPR Issues

- Due 30 days after the end of each quarter of grantee's operating year
- The QPR form is now accessible through our website: <u>http://ncceh.org/bos/grantees/</u> (scroll to the bottom)
- APRs need to be requested from CHIN (until ART license) prior to filling out the QPR
- Even if you don't have a QPR due, please open the form and begin filling it out due dates will automatically generate for your records
- Turning in QPRs on time is one of the criteria on the CoC Application Scorecard
- NCCEH will no longer be sending out QPR due date reminders; it is up to the grantees to keep track of QPR due dates

- 2012 Intent to Apply Form must be filled out for:
 - All current grantees that are up for renewal this year
 - Any agency that is interested in applying for new funding in 2012 (Please note: if your Regional Committee did not elect a Regional Lead in Jan/Feb/March of this year, you are ineligible for 2012 CoC funding)
- Regional Leads should inform their Regional Committee Members
- Interested Applicants should refer to the 2011 Scorecard to review criteria for funding:
