### **CoC Application Update**

- CoC Registration to HUD was due Oct. 1 and was completed by NCCEH as staff of the BoS CoC
  - Thanks to all grantees for your quick responses in completing the Grant Inventory Worksheet!
- FY2012 Geo Codes and Preliminary Pro Rata Need Amounts are also posted on HUD HRE:

- Pro Rata amounts have increased since FY2011
- Eligible Regional Committees will receive pro-rata sheets
- CoC NOFA is expected in mid- to late-October

### Important CoC Application Changes

- New CoC components: Permanent Supportive Housing, Rapid Re-Housing, Transitional Housing, Supportive Services Only, and HMIS
- Eligible costs: Acquisition, Rehabilitation, New Construction, Leasing, Rental Assistance, Supportive Services, Operating Costs, HMIS
- Rental Assistance may only be administered by:
   PHAs and Units of Local Government
- Public Housing Authorities cannot be new applicants, but can be contracted to administer rental assistance
- 25% CoC wide match (in-kind or cash), except for leasing
- 1.25% Planning funds

#### Intent to Apply Form for CoC Funds

- 2012 Intent to Apply Form must be filled out for:
  - All current grantees that are up for renewal this year
  - Any agency that is interested in applying for new funding in 2012
- New Intent to Apply Form COMING SOON!
  - Editing Intent to Apply based on new eligible activities
  - Regional Leads should inform their Regional Committee Members

#### New CoC Board Requirements in Interim Rule

- The CoC Interim Rule codifies a CoC governing body, or board
- HUD requires two characteristics for all board compositions. These characteristics are that:
  - the board must be representative of the relevant organizations/projects serving subpopulations of homeless persons within the geographic area,
  - and include a homeless or formerly homeless person.
- No board member may participate or influence discussions or decisions concerning the award of a grant or other financial benefits for an organization that the member represents.
- Continuums will have 2 years from the effective date of the interim rule to establish a board that meets the criteria.

For 2012, the Steering Committee will serve as the NC BoS Board.

### **BoS CoC Data Quality**

- NCCEH staff has worked with CHIN staff on a plan to improve the data quality of the BoS CoC
  - Every other month, NCCEH and CHIN are reaching out to BoS CoC agencies with low DQ scores (cc'ing Regional Leads)
  - CHIN runs a DQ Follow-Up Report for the agency and then works with them to raise their DQ score by fixing errors
  - Daniel Reinholz is the BoS CoC CHIN DQ contact
- CHIN is now offering an online Data Quality information session for participants in the BoC CoC
