Brief History of Homelessness Response

- □ 1980's (First Response—Emergency Shelters)
- 1990's (Continuum of Care Created based on Housing Readiness Model)
- 2000's (New Permanent Supportive Housing emphasis, Move from managing homelessness to ending homelessness, Housing First, Congress mandates HMIS, Local Ten-Year Plans to End Homelessness)
- 2010's (Use of evidence-based practices, new RRH & Prevention emphasis in addition to PSH, Federal Strategic Plan to Prevent & End Homelessness)

Research & Data

- Chronic Homeless and Housing First Research =
 Housing Plus Services is effective and cost-efficient
- New research shows effectiveness of Housing Plus Services approach for families
- Housing PLUS Services can work for all individuals and families who experience homelessness
 Difference = Length & Intensity of Assistance

HEARTH Legislation Enacted



President Obama signed the HEARTH Act on May 20, 2009.

It was the first significant reauthorization of HUD's McKinney-Vento Homeless Assistance Programs in nearly 20 years.

It required the U.S. Interagency Council on Homelessness to create a federal plan to end homelessness.



HEARTH Act Purpose

"to establish a Federal goal of ensuring that individuals and families who become homeless return to permanent housing within 30 days"

HEARTH Act Purposes - Sec. 1002(b)

Opening Doors: Federal Strategic Plan to End Homelessness

FOUR GOALS:

- □ Finish the job of ending chronic homelessness in 5 years
- □ Prevent and end homelessness among Veterans in 5 years
- Prevent and end homelessness for families, youth and children in 10 years
- Set a path to ending all types of homelessness

 Objective 10: Transform homeless services to crisis response systems that prevent homelessness and rapidly return people who experience homelessness to stable housing



Our Current System

- 1. Experience housing crisis
- 2. Move from system to system seeking support
- 3. Lose Housing
- 4. Enter Emergency Shelter
- Address barriers to housing while in the shelter or transitional housing



A New Approach

- 1. Experience housing crisis
- 2. Reach out for support
- Providers assess for housing risk and make referral to housing stabilization services
- Based on client need, appropriate services are provided (e.g. short or long term rental assistance, wraparound services, landlord mediation and housing search)
- Client may need to stay at a shelter while receiving stabilization services



Targeted Homeless \$

(and who is required to use HMIS)

- HUD McKinney-Vento Homeless Assistance Funding
 - ESG (Emergency Solutions Grants formerly Emergency Shelter Grants)
 - block granted to states (was 10%, is now 20%)
 - Continuum of Care Competition
 - 80% distributed through national competitive process (was 90%, is now 80%)
- □ ARRA: Homelessness Prevention & Rapid Re-Housing Program (HPRP)
- Veterans Administration
 - Per Diem Program
 - Supportive Services for Veteran and their Families (SSVF)
 - HUD-VASH
- DHHS





System Change Strategies

- Expanding Rapid Re-Housing Capacity
 - With HPRP funding ending, we need to work to maintain Rapid Re-Housing Capacity, not just expand it
 - Rapid Re-Housing eligible under ESG this year
 - Rapid Re-Housing will be eligible under CoC in the future
 - Private dollars can fund Rapid Re-Housing
 - Be creative! Look at other funding sources that can support rental assistance, other financial assistance and case management



- Converting Shelter Beds to Rapid Re-Housing Resources
- □ Shelter is a temporary fix for an immediate need
- Reinvesting resources in Rapid Re-Housing will result in a need for fewer shelter beds
- □ ESG funding will make this shift over time!

System Change Strategies

- Shelter Diversion
 - Reduce new entries
 - Reduce the demand for shelter beds
 - Reduce program wait lists

- □ Targeted Prevention
 - Extremely difficult to predict who will become homeless
 - New York City Controlled Study:
 - 80-90% do not become homeless without assistance
 - Only 10-20% who receive prevention assistance would have become homeless without it
 - Make your prevention problem serve a people that look like people in shelter

System Change Strategies

- □ Creation of Permanent Supportive Housing
 - Ensure your community has PSH options for persons with disabilities and high keeping housing barriers who need long-term support



- □ Exits from Permanent Supportive Housing
 - Work on an exit plan for households who have stabilized and are ready to move on

 - Will be required by HUD
 - More details to come
- □ Common Barrier Assessment and Targeting Tool


- □ Performance Improvement Process
 - □ Improving what you are already doing
 - Use data to inform your practice!

 - □ Don't duplicate services!
 - Link up with others who have resources

NEXT STEPS to STAY FOCUSED

Act Strategically

Transform homeless services to rapid response systems to focus on housing stabilization. Centralized and coordinated intake is key to making this work. Offer alternatives to shelter admission whenever possible, make shelter available, and ensure quick housing placement and housing retention.

Act Strategically

- Collaborate with Public Housing Agencies to identify how families and individuals who are homeless can be prioritized for housing
- Commit to using data as a management tool.
 Review your community data to identify system and program strengths, weaknesses, and opportunities for improvement.
- Work collaboratively and build relationships to streamline resources and efforts.
