# Tight Timeframe for Deadline

# State Deadline = All application materials due October 19!!!

All applications must be complete.

If your application is not complete, or if your regional information is not to us by October 19<sup>th</sup>, you may not be able to receive funding.

Final Submission Deadline = November 9<sup>th</sup>!!!

# NOFA Changes

- Selection Process (section A3a)
- Certification of Consistency with the Consolidated Plan (section A3d)
- Coordination with ARRA programs (section A3e)
- HPRP participation (section A3f)
- S+C and FMR (section A3i)
- Samaritan Bonus replaced w/ PH bonus (section A3k)
- Institutional residency requirement = 90 days (section A3I)

# Key Changes for this Year

- One-Year renewal awards will be announced in Fall 2009 & New awards in Spring 2010
- Con Plan certificates will go with Exhibit 1 not separately in Exhibit 2
- Process expected to coordinate with ARRA/HPRP
- Housing emphasis and leveraging will only count for new projects

# Key Changes Continued

- SHP and S+C can apply for 100% FMR only; no overage
- PH Bonus is not limited to chronically homeless (but CoC's are encouraged to use some for chronic)
- All grants awarded in 2002 cycle must be renewed this year!
