NOFA AND PROJECT APPLICATIONS

Changes in the NOFA

- One-year renewal awards for S+C and SHP will be announced in fall of 2009
- Consolidated Plan certificates will go into Exhibit 1 instead of Exhibit 2
 - applicants in areas that have their own Consolidated Plan (not the state plan) must submit their area's plan
- CoC process is expected to coordinate with ARRA and HPRP programs
 - o must include narrative in Exhibit 1 about this coordination
- Housing emphasis and leveraging will only count for new projects
- SHP and S+C can apply for 100% FMR only no overage is allowed
- Permanent Housing Bonus (Samaritan Bonus) is no longer limited to chronically homeless individuals it is now for individuals and/or families with disabilities
- All grants awarded in 2002 MUST be renewed this year

Responsibilities: ALL BoS Agencies

- Survey will be sent out to ALL BoS agencies (regardless of whether they receive funding) asking about services offered and ARRA/HPRP coordination
 - must be filled out by October 12
 - \circ $\:$ leads from Regional Committees will be asked to help follow up with agencies that don't respond

Responsibilities: Applicants Only

- The process for entering application information in esnaps was discussed
- PDF version of application, most recent APR, and local Consolidated Plan certification (if applicable) is **due to NCCEH by 5 pm October 19**

Next Steps

- The Steering Committee discussed the October 19 project application deadline and how to handle late submissions
 - Steering Committee voted that applications submitted after the 19th will be discussed on a case-by-case basis and voted on during Nov. 3 meeting
- Scorecard Committee will meet October 9
- Project Review Committee will meet October 19 to discuss scoring applications and October 26 for final ranking
 - may send out recommendations to applicants for essential changes
 - needed changes must be made by applicants by October 29
- One person from each regional committee should serve on the Scorecard Committee and the Project Review Committee
 - NCCEH will email regional committee leads to get names if area is not represented
