- b. SSA has passed a policy that makes it possible to ban individuals from their offices
 - i. Can be banned up to 2-3 years
 - ii. Has potential to be punitive
 - iii. Emily is working with national advocacy group to get this revised or reversed
 - iv. If anyone's clients are banned, please find out the circumstances and contact Emily.
 - v. TJ- one thing to keep in mind that the SSA office is a federal building that have certain rules
 - 1. Make sure applicants don't have weapons, etc.
 - 2. Threats, verbal threats
 - vi. Emily to send email with more information on this new policy.

IV. Achievements of 2011

a. James Davis- SSA dictated that an applicant have a payee who was awarded benefits

- i. Was able to get a letter from a doctor to state that the applicant can manage his own funds
- ii. TJ- Definitely a big achievement to be able to advocate for applicants when it comes to payee
 - 1. Remember SSA 787 is the form to use to get a payee designated or to designate the applicant as the payee
 - 2. Can be a good idea to carry copies of this form with you
- b. Linda Mandell- Have developed good relationships with organizations in the community
 - i. Last year I started a good relationship with PORT Human Services
 - 1. Have been very helpful in signing Medical Summary Reports
 - ii. Worked with Nurse who supervises Emergency Department Caseworkers
 - 1. Very helpful in obtaining a doctor's signature from ICU
 - 2. Without her help I don't think I could have reached the doctor
 - iii. TJ- Building relationships is key
 - 1. Using "people skills" to improve work with agencies
 - 2. Can lead to more cooperation with signatures
- c. TJ Emwanta- Developing relationships in the community with key agencies
 - Scheduling SOAR presentations of mental health providers to educate frontline staff
 - 1. Was able to get a clinical supervisor to the presentation
 - 2. Clinical supervisor saw how SOAR was different from "business as usual"
 - 3. Clinical supervisor now instructs doctors to sign reports
 - ii. Key is to target people within agencies with connections to doctors to sign reports
- V. Setting Goals for 2012
 - a. Goal setting allows us to:
 - i. Think ahead
 - ii. Motivates us
 - iii. Helps us to organize time and resources
 - iv. Allows us to track our goals and progress
 - b. Found a tool that helps to set "SMART" goals:
 - i. Specific
 - ii. Measurable
 - iii. Attainable
 - iv. Relevant
 - v. Trackable
 - c. Examples provided by Emily
 - i. Develop relationship with local provider or hospital
 - ii. Work towards Certification
 - iii. Build a stronger community group to advocate for SOAR
 - d. TJ- I want to become a Certified Disability Worker.

- i. Found a certificate program through online course with Cornell University
- ii. Currently working to accomplish this
- e. James-I would like to get my SOAR Certification in 2012.
 - i. TJ- SOAR Certification requires you to do a certain number of cases
 - 1. Checklists, Medical Summary Reports, etc.
 - 2. 6 cases total
 - 3. Exams, self-assessment exam online
 - 4. Moli- Is there a timeline requirement?
 - a. James- no timeline on Certification outline
 - b. Moli-I may be getting mixed with something else
 - ii. TJ- All you have to do is go to the NCCEH website for more information
 - 1. Information under "SOAR Certification"
 - 2. Do not have to be doing SOAR cases for a certain amount of time
 - 3. Total of 6 cases needed
- f. Sheila- I would like to get the three cases I have in process approved and learn what I can do better in the process.
 - i. TJ- very true that the more cases you do the more confident you are
 - ii. Sheila- I don't want to stop and give up on this.
 - iii. TJ- Can be tough when you have other case management tasks needed.
 - iv. Sheila- I need to make time to do SOAR applications
 - 1. Dedicate a day or certain hours to work on applications.
 - 2. TJ- great to have a big picture goal and then smaller goals beneath that.
 - 3. TJ- SOAR requires time so it would be great to have some set aside to complete applications
- g. Dianna- I am extremely excited about this job because of tracking outcomes and results.
 - i. I just started in December with 7 referrals.
 - ii. My challenge this year is trying to collaborate and to do better outreach to get more referrals.
 - iii. I have done a number of presentations and meeting with clinical directors with local agencies with no change in referrals.
 - iv. Would be great to collaborate with a local health provider to get referrals.
 - v. Other goals: Certification, getting more doctors on board, etc.
 - vi. Linda- Do you have a Continuum of Care?
 - 1. Dianna- I think so.
 - 2. Linda- We have monthly meetings in my area
 - a. Can be a great way to reach a lot of homeless service providers
 - b. Good referral source, depending on what agencies are there
 - 3. Dianna- That's a good idea.
 - vii. Dianna- I was at a Mental Health Roundtable Meeting this morning
 - 1. They also provided more resources I could tap into
 - 2. Goodwill, churches, etc.
 - viii. Dianna- I've found some challenges within outreach in a rural community.

- ix. Linda- Local police can be very helpful.
 - 1. Dianna- good idea, that was brought up today too
 - 2. Dianna- I got a contact for someone at the local jail to follow up
- x. TJ- The Point In Time Count is happening next week
 - 1. Could provide a way to outreach in the community
 - 2. Our outreach team finds a number of people to refer during the count and by going out into the community.
- xi. TJ- You will be surprised with the number of referrals you will start to get.
- h. Linda- Win some more cases.
 - i. I've become more judicious about the cases that I continue.
 - 1. Developing a better sense about who to pursue SOAR cases with.
 - 2. In doing that, I've improved my track record
 - ii. TJ- Prioritizing SOAR cases can be hard
 - iii. Dazara- Just wanted to remind everyone that PRA is holding a webinar nextWednesday afternoon to help identify possible SOAR applicants
 - 1. Go to www.prainc/soar.com
 - 2. Instructions on the website to sign up
 - iv. TJ- Emily will review these webinars with us a lot of times
 - v. Moli- I can't go to the webinar, is there a way to get that information afterwards?
 - 1. Dazara- Slides will be posted on the PRA website
- Jackie- Reach out to other shelters in the area for referrals.
 - i. I only got one referral from a shelter.
 - ii. Working with the CoC as well.
 - iii. Going to set up a meeting with the men's shelter.
 - iv. Have had some difficulty in Vance County/rural community
 - v. Dazara- Are there any PATH teams in rural areas?
 - 1. TJ- There are some including Statesville, NC
 - 2. TJ- I'm not sure of others.
 - 3. TJ- There are some changes that have been going on with the PATH program in NC.
 - a. Many of them are based in metropolitan areas
 - b. Emily would be a better resource for answers
 - vi. TJ- Rural Area Ideas
 - 1. Churches do a lot of outreach
 - 2. Police
 - a. We actually go to the squad meetings to talk
 - b. Participate in training police officers about mental health issues
 - 3. Libraries could also be a good resource
 - vii. TJ-I can suggest this as a topic for another Dialogue Call.
- j. Violet- We are not getting referrals from the hospital that we are anticipating.
 - i. TJ- sounds similar to Dianna and Jackie.

- k. Moli- My primary goal is to get started.
 - i. I work for a mental health agency in Person County
 - ii. Some issues of timing in the number of hours to complete cases that are not billable for these applications.
 - iii. The ultimate benefit of the client getting benefits is attractive, but still working out how to complete these applications.
 - iv. I have gotten several referrals from the case management team.
 - v. I've determined 3 to be "good" referrals so far.
 - vi. One question I have is if a client has been denied and in an appeal. Are they still a candidate for SOAR?
 - 1. Linda- one thing to check is if they have an attorney
 - 2. Linda- If not, you can at any point become their 1696 Representative to help out
 - 3. Linda- If they do have an attorney,
 - a. You can't be a 1696 Representative
 - b. They can transfer from an attorney but may still be some charges from the attorney for the work already done
 - 4. TJ- SOAR really focuses on the initial application
 - a. Appeals can be more challenging because you are picking up the case in mid-stream
 - Have to jump in really quick to make 60 day deadlines for Reconsideration and Appeals
 - Not a lot of time to gather medical records and write reports
 - ii. Cases are also expedited because applicants are homeless
 - vii. TJ- Keep in mind that Medicaid benefits will be awarded back to the PFD.
 - 1. Your employer could look at billing Medicaid retroactively for services.
 - 2. Moli-I am pushing that point for sure.
