### **Discussion**

Our plan today was to talk about ESG however NC DHHS has not released the 2013 ESG application yet so we are not able to discuss specifics. We did talk over the general process for applying and take questions. NCCEH will give NC DHHS a list of questions and comments about ESG from BoS.

No word on fiscal agent status (agency contracting directly with state, making contracts with subgrantees). It is not clear but this probably will not be required in this cycle because there were so many problems this year. Examples of fiscal agents: cities, United Ways, other nonprofits

NCDHHS will be doing a training on grant requirements. It will likely be a similar app to last year with some clarifications, probably the same format. The project applications will come from agencies, regional applications from regional committees (not at BoS level). There is a lot going on a state DHHS/local DSSs – DOJ settlement, Affordable Health Care Act rolling out, etc.

Reimbursements have been not working – state lumps them and pays several at once but it is hard to tell what is being paid when. This was more smooth with HPRP, now a nightmare. There are different contract people working at DHHS plus there is not much administrative support money.

Will there be funding for prevention? In 2013, this funding will need to be targeted – there is good information about this on the NAEH website. The HUD focus is to use ESG money for RRH. Research shows (NY study) that 9 out of 10 people who received prevention money would not have become homeless.

How to find out what shelter funds are available? There will be a table within the application. Likely to be less money available this year. We will only have FY 2013 money, plus this cut. For emergency response and housing stabilization, DHHS has percentage goals but we don't know this conversation.

There is one-on-one monitoring from NC DHHS available in the form of an audit/site visit – just have to request this.

Success story: a chronically homeless man in Pitt County got S+C money and RRH money to get into housing. There is a dramatic difference in his life, his appearance.

In Wilson County the prevention case load is decreasing – they are working with the school system, using RRH to get a quick turnaround for people in shelter. The problem is not finding affordable housing – prevention and RRH money is there.
