Topics Covered: All Things Privacy

Synopsis: The morning privacy session will consist of a comprehensive explanation of the new privacy rule as well as an introduction to the new privacy documents for the North Carolina user base. MCAH will cover privacy in detail and how agencies should implement moving forward. The end of the morning session will include an interactive dialogue/Q&A session where users can have questions answered about the privacy model.

Topics Covered: System modules and functionality, use of Enter Data As and backdating, a brief workflow overview, visibility and sharing, and a CoC agenda section that includes visibility, sharing, mapping business practices on to the system, intro to reports, an overview of recorded trainings including where to find them, and how to prepare for the implementation week.

Synopsis: This session will cover a variety of topics and is not meant to be completely comprehensive; rather, it will be an introduction to key changes, uses and new functionalities that will be available to users on the system. From these sessions, users will be encouraged to take the various trainings that will be available on the MCAH website for a more "indepth" experience. MCAH will also be working much more closely with communities during direct meetings with the CoCs, agencies and key partners that will be scheduled throughout late April, May and June.
