# 2015 PIT data now available by county and by BoS Regional Committee

- NCCEH has historically published BoS PIT divided by county
- 2015 county data adds some categories:
  - Location (shelter, transitional, unsheltered)
  - Chronically homeless individuals, families, and total
  - Veteran individuals, families, and total
  - Youth households (new HUD category in 2015)
- 2015 BoS PIT also divided by Regional Committee
  - Same categories as county info

## Coordinated Assessment

#### Here's the big picture re: plan review

- Expecting 26 plans
  - 10 approved by Steering Committing/implementing
  - 5 additional have CAC recommendation
    - 1 for Steering Committee review today
    - 4 in revisions process with NCCEH staff
  - 11 for further CAC action
    - 5 in revisions process with NCCEH staff
    - 4 in process of passing threshold
    - 2 working on initial submission



# Pitt plan presented for Steering Committee review today

- CAC strengths of this plan
  - 24 hour coverage through telephone center
  - Good community resources available and engaged
  - Weekly meetings to determine client referrals
  - Thorough answer for oversight
- Discussion

## Proposed change to BoS Coordinated Assessment is using NC 211 as a resource database

- NC 211 has increased functionality and coverage in NC
  - Mobile app
  - Website
  - Phone
  - Covers all 100 counties
- Bringing NC 211 and Coordinated Assessment together can maximize efficiencies
  - NC 211 has community members updating info
  - BoS Regional Committees and community members will have readily accessible info



## Recommendation: BoS Reg. Cmtes. use NC 211 as resource database

- Future steps
  - NC 211 as prevention/diversion
  - Other national experts are spending MORE time on diversion, getting good/better results
  - Pilot programs in Onslow, Alamance & Henderson to explore options

# Outcome measurement has begun for BoS Coordinated Assessment

- Live training held July 1
  - Recording will be posted on NCCEH website
- Google form for submitting quarterly reports
  - Comprehensive!
  - Created by CAC
- Tally sheet for data collection
  - Not required, to use as needed
- NCCEH staff will email Regional Leads and Coordinated Assessment leads with instructions and links



#### CA Outcomes will be reported quarterly

- First report due Oct. 15
  - July 1 Sept. 30 time period
- Staff and CAC will review RC submissions in late Oct./early Nov. to determine review standards, red flags, etc.
- Subsequent reports due Jan. 15, Apr. 15, July 15 for previous quarter



### CoC Grant Competition: Scorecards

## 2015 Renewal Scorecard has some changes from 2014 version

- Each section has own independent number
- Some items moved around in sections
  - New section at end: Deductions
- Possible scores broken out by project type
  - Not all projects are eligible for all points
- Wording for Services Plan reworked
  - Plan for finding alternate funding sources for services,
     not a justification of why services are necessary



## Further changes to the 2015 Renewal Scorecard compared with previous versions

- Minimums lowered for 2 sections: HUD/BoS Priorities
   & Project Performance (APR Data)
  - Majority of projects did not meet these minimums in 2014
- Change in language from "threshold" to "standard"
- Some objective measures moved to Staff Scoring
  - Energy Star, % housing funds requested
- Added question about % of beds prioritized for people who are chronically homeless



## Further changes to the 2015 Renewal Scorecard compared with previous versions

- Grantee relationship to community & regional performance removed
  - Information to be presented in other formats
    - Grantee: commitment with the CoC to fulfill obligations
    - Regional Performance: Regional Committee report cards, dashboard or some such



## Further changes to the 2015 Renewal Scorecard compared with previous versions

- Key elements of PSH
  - Moved from points to standard
    - As stated would change in 2014 scorecard
  - Grantee documentation required
  - Moved to Combined Scoring section (from Staff Scoring)



# 2015 New Project Scorecard is also up for approval

- NC BoS has not used a new project scorecard in several years
  - Have not had funds for new projects



# New Project Scorecard has consistency with Renewal Scorecard

- Combined Scoring & Staff Scoring sections
- Sections have own independent numbers
- Possible points by project type where there are differences
- Regional performance section also removed
- Deductions moved to section at end
- "Standard" rather than "threshold"



## New Project Scorecard also has new questions and differences from Renewal Scorecard

- New questions
  - RRH projects must be existing ESG grantee
  - Housing First project
- Differences
  - Agency Relationship to Community is included



## CoC Grant Competition: Next Steps

# FY 2015 CoC Grant Competition has begun, will continue to ramp up

- HUD is closing registration July 8
- After registration
  - HUD is likely to publish NOFA in July
  - Project and collaborative applications likely to be in process July and August



## CoC Intent to Apply form is active and receiving submissions about new projects

- Agencies interested in applying for NEW projects
  - Complete FY2015 CoC Intent to Apply form

  - Renewal projects do not need to complete this form
  - New projects are 1 year contracts

# NCCEH staff need current APRs for all grants for the CoC application
