Topics for the SOAR Caseworker Meeting

The caseworkers brainstormed about topics that it would be helpful to discuss at the Annual SOAR Caseworker meeting. The agenda will include an overview of SOAR in 2015 and two to three topics to aid caseworkers in completing cases in the community. The topics that are not chosen for the meeting will be topics for future SOAR Dialogue Calls. SOAR caseworkers, SSA and DDS may be asked to present on topics as fitting. The following is the list of topics:

- Presentation about consultative exams
 - O How does DDS choose the doctors that they use? Do doctors sign up for these exams?
 - O How much weight is given to a CE over their primary care physician?
 - O How can you advocate for a CE?
- Issues with medical records
 - o Is there a better process for gathering these?

- What do you do when the records don't match what you see?
- How do you approach the provider to discuss the discrepancy in what you see and what the records discuss?
- Caseworker tips
 - How do caseworkers organize themselves?
 - o How do caseworkers manage files?
 - O Do other caseworkers take case notes and who reviews these?
