Introductions

- Emily Carmody, NCCEH, Raleigh- Great SOAR training in October, looking at updating trainings for new mental health listings
- Diamond Jenkins-Nelson, Southlight, Raleigh- Had 1 approval and 3 denials, 1 denial was pulled back by quality review for a consultative exam so the decision may not stand
- Natasha Posey, Southlight, Raleigh- No significant updates, facing some challenges with engaging applicants
- Tashira McGill, LATCH, Durham- Durham SSA moved and the fax line is offline until November 2nd
- Candice Chilton, LATCH, Durham- LATCH program looked at most recent Medicaid billing since 2010, total is \$5,190,946 with 15 people whose information is not included yet, average per patient is \$34,606
- Sandra Johnson, Pisgah Legal Services, Asheville- slow at the moment, lots of referrals but many are not homeless or are in medical record gathering stage
- Elizabeth Lewin, PATH Team, Statesville- Still loving my job and had some approvals

Comments on Expanded Medical Sources

- SSA is seeking comments on new rule to expand medical sources to Nurse Practitioners and a possible expansion to Physician Assistants and Licensed Clinical Social Workers
- Comments are due November 8th

- Emily will resend the template for comments to SOAR caseworkers
- There will be opposition to these changes so input from SOAR caseworkers is vital

Updates to SSA Mental Health Listings

- SSA announced that they will begin using updated mental health listings as of January 17, 2017
- SOAR Caseworkers can find the updated mental health listings starting on page 66161-66168: <u>http://bit.ly/2duFQM9</u>
- While the listings are changing, the backbone of the SOAR model stays the same:
 - Acting as the Representative
 - Gathering and sending medical documentation
 - Writing Medical Summary reports
- Highlights from the changes include:
 - Listing titles are updated to reflect terms in the DSM-V
 - New adult listings:
 - Neurodevelopmental disorders
 - Eating Disorders
 - Trauma and stressor-related disorders (PTSD)
 - Substance use disorder has been removed
 - Four areas of functioning for all listings is changing
 - Understand, remember or apply information
 - Interact with others
 - Concentrate, persist or maintain pace
 - Adapt and manage oneself
 - o Activities of Daily Living can be used as examples in all of these functioning areas
 - Functioning will be rated on a scale of 1-5
 - 4 is marked limitations and 5 is extreme limitations
 - A person will need to have two functioning areas with marked limitations or one area with extreme limitations to meet the listing
- The national SOAR program will be holding webinars this fall to prepare caseworkers for the changes
- It is anticipated that this will be a topic for the SOAR caseworker meeting
- NCCEH will keep everyone posted on trainings and resources so caseworkers feel comfortable writing Medical Summary Reports for the new criteria

Planning for SOAR Caseworker Meeting

- NCCEH is working to find a location for the December 8th SOAR caseworker meeting
- SSA and DDS have indicated they can both attend
- Topics to consider for the agenda
 - o New mental health listings- get input from DDS on the new listings
 - Reviewing data from the past year and how that fits in with trends
 - How to address medical records that show bias or are not supportive of the case

- Getting quality referrals
 - How to develop relationships to get good referrals from agencies
 - How to engage new systems in sending referrals (jails, prisons, Dept. of Social Services)
- Engaging service providers to support SOAR applications by providing information and reducing barriers to services and records
- Emily will work on pulling together the agenda for the meeting and contact SOAR caseworkers to assist in activities
