Minutes

Call to Order

The last bullet should read, "All PIT data should be sent to Talaika by February 2nd, it is due to the Balance of state by February 17th", not ... February 7th. A motion was made by Hayward Humphrey to accept and approve the minutes of the last meeting with the necessary corrections and it was seconded by Tina Rodgers.

Balance of State Updates - (Nicole Boone)

- Nicole gave a brief summary of the BoS Steering Committee Meeting.
- Highlights from the meeting:
 - o Staff update Ehren Dohler has been hired as a Project Specialist
 - There was a webmaster training on February 9th Lakitra participated in the online training
 - There will be a Coordinated Assessment Webinar today at 3pm Melissa will be participating
 - o On Tuesday, March 21st, Trillium will be host a workshop geared toward the funding process in Greenville for Regions 10, 11, 12 and 13

Discussion of Meeting Locations

- There was a discussion about finding a new meeting location and two options were given. Option 1 includes keeping the meetings in Ahoskie and having a call in number for those that may not be able to travel, but would still like to participate in the meeting. The second option is to move the meetings to a more central location like Chowan County.
- The committee agreed to keep the meetings in Ahoskie and offer a call in option.
- The group came to the consensus that more people should be invited to be a part of the committee so there would be representation from all of the counties within the region.
