Grant Transfers Workgroup Proposal

A workgroup was formed to develop a new CoC grant transfer process.

• Goals:

- Increase transparency
- Find agency that is best fit for grants
- Give CoC opportunity to evaluate agencies



The workgroup met in November to develop the new process.

• Workgroup members: Mike Bridges, Destri Leger, Kristen Martin, Talaika Williams

- Met twice in November
 - Discussed goals and context
 - Created framework for new process
 - Developed documents to be used in new process



The workgroup has recommended a proposed process.

- Proposal posted at <u>www.ncceh.org/bosminutes/</u>
- Process includes 3 parts:
 - Announcement of available transfers
 - Shared through email, website, and agency engagement
 - Submission of documentation from interested agencies
 - Letter of Intent from all
 - Written Proposal from non-grantees
 - Impartial review
 - Conducted by Project Review Committee
 - Recommendation approved by Steering Committee



Steering Committee is asked to approve the grant transfers process & documents.

- Process will fall under existing significant change policy
 - Note: Significant Change Policy was added to the Governance Charter in November.

HMIS Lead Discussion

NC HMIS Background

- NC HMIS includes 12 CoC
 - Governance Committee includes 4 BoS seats
- NCCEH is the BoS HMIS Grantee
- MCAH is the NC HMIS Lead Agency, selected by the NC HMIS Governance Committee
- NCCEH contracts with MCAH on behalf of the BoS, CoC for HMIS services and use of Mediware/Bowman ServicePoint software
- MCAH holds contract with Mediware/Bowman
- Contract period July 1 June 30



Challenges with NC HMIS

- Difficult for NCCEH to meet HMIS grantee and Collaborative Applicant responsibilities with MCAH serving as HMIS Lead Agency
- Administrative and Training Concerns
- Visibility, system configuration, other use of software concerns
- Software concerns
- NCCEH, BoS reps, other CoCs have taken concerns to NC HMIS Governance Committee, attempted to resolve
- NCCEH requested an RFP for a new NC HMIS Lead Agency in July 2017. Governance Committee considered in August. Split vote, but did not pass.
- NCCEH's Board voted to no longer contract with MCAH current contract ends



Recommendation: Create new regional HMIS to meet BoS HMIS needs

- Designate NCCEH as HMIS Lead
 - Durham and Orange CoCs have approved
- NCCEH contracts with Mediware/Bowman directly
- NCCEH contracts with Institute for Community Alliances for support during transition
- Change system settings in ServicePoint
- NCCEH oversees all training, administrative pieces
- Evaluate software, possible RFP for new software



What Users Can Expect

- Training, all HMIS materials hosted at ncceh.org
- New url to log in to ServicePoint
- Short down-time for data entry
- Possible week down-time for reports
- Agencies that serve CoCs that will remain on NC HMIS will need data in two databases
 - Possible tech solutions
- Updates, clear guidance throughout process



ESG Update

The state ESG office announced 2017 awards on 11/22

- All RCs should have received announcement of all 2017 ESG awards
- Award letters showed:
 - ESG funds allocated per program and programs not funded
 - Individual program sheets with conditions of funding or reasons for reduced or no funding



The state ESG office announced 2017 awards on 11/22

- Regional Committees can submit a plan to reallocate funds not awarded in initial application by December 15
- Programs with special conditions must submit all documents/explanations by December 15 to access awarded funds



The NC BoS CoC received less ESG funding year over year

Emergency Response	\$ 819,792	\$ 720,406
Housing Stabilization	\$ 1,086,876	\$1,037,059
HMIS	\$22,076	\$ 24,001
Total Funding	\$ 1,928,744	\$ 1,781,466

Key takeaways (from the ESG Office):

- Regions did not scrutinize project applications
- Applications were incomplete: All attachments not included
- Applicants did not answer the question asked



The ESG office had higher expectations for this year's applications

- Project applications were reviewed for:
 - Application completion
 - Submission of all requested documents
 - Thresholds
 - Application issues (i.e. consistency, quality of programs)
 - Spending history
- Many programs were awarded reduced funding or not awarded any ESG funds requested

- Set CoC and ESG funding priorities, including guidelines for potential reallocation.
- Develop goals for Regional Committee and CoC performance (system performance measures, possibly goals like ending chronic homelessness)
- Develop performance measures and guidelines for grantee performance.

2018 Point-in-Time Count & HIC

The 2018 PIT & HIC will be held the night of January 31.

- Note the change in the date from previously announced
- Point-in-Time Count = people experiencing homelessness
 - Emergency shelters
 - Transitional housing
 - Unsheltered situation
- Housing Inventory Count = homeless programs
 - Emergency shelters
 - Transitional housing
 - Rapid re-housing
 - Permanent supportive housing



Regional Committees should begin planning early.

- Create PIT/HIC committee
- Choose PIT/HIC lead(s)
 - Regions 3, 5, and 11 still need to identify their lead
- Involve all relevant stakeholders in planning process
 - Programs doing sheltered count (ES,TH)
 - Veteran service providers
 - Youth service providers
 - Homeless / formerly homeless people
 - Agencies reporting HIC information



NCCEH will provide PIT/HIC forms and training.

- NCCEH is creating forms for data collection now
 - Using HUD guidance
 - All RCs <u>must</u> use NCCEH forms
 - Forms will be posted at <u>www.ncceh.org/pitforms/</u> by the end of December



NCCEH will provide PIT/HIC forms and training.

 - Pre-recorded trainings on how to use each form



Regional Committees should provide training locally.

- RCs should be prepared to educate local providers/volunteers on local process and ensure they understand how to fill out forms and submit data.
 - Set date for training close to PIT/HIC date
 - Make mandatory for participants in the count
 - Recommend in-person meeting with call-in/web sharing option
 - Define specific process for unsheltered count and identify local leaders of the process



Coordinated Assessment

The CAC changed language in the Prevention and Diversion Screen

- The CAC proposes to change Question 2 (Domestic Violence question):
- 2. Are you currently residing with, or trying to leave, an intimate partner, family member, caregiver, or other person in your home who threatens you or makes you fearful?



The Steering Committee needs to vote on this change.

Letters of Support

Many funding sources require CoC letters of support

- How should the CoC handle these requests?
 - Make sure the program truly reflects CoC priorities.
 - Process should differentiate between funding streams (a developer would participate differently than a service provider, for instance)



SSVF Letters of Support

• SSVF providers need letters of support from CoCs they cover for the renewal funding NOFA due January 12.



SSVF letters need to include two parts:

- 1. A detailed description of the applicant's participation in coordinated entry process or planning activities and overall community planning efforts.
- 2. The applicant's contribution to the CoC's coordinated entry process capacity building efforts, detailing the specific nature of this contribution.



NCCEH staff confirmed with SSVF providers that they are committed to:

- Fully implementing all aspects of the NC BoS CoC Plan to End Veteran Homelessness and all aspects of each Regional Committee's Veteran plan that the SSVF provider covers.
- Ensuring Veterans in every county they serve have access to SSVF and other services, including setting up systems for passive and assertive outreach.



NCCEH staff confirmed with SSVF providers that they are committed to:

- Maintaining a region-wide by-name list in HMIS, including any necessary data entry, such as entering data for non-HMIS participating agencies.
- Setting up a regular meeting, at least every two weeks, to go over the by-name list, case conference currently homeless Veterans, and ensure efficient referrals to housing. This meeting must include representation from the VAMCs and programs that run permanent housing.



NCCEH staff confirmed with all SSVF that they are committed to:

- Attending regular coordinated assessment case conferencing meetings, whether or not the Veterans meeting is part of the CA meeting.
- Taking all referrals through coordinated assessment. If coordinated assessment does not provide referrals to SSVF or is not functioning in another way, SSVF will work with CoC staff and the Regional Committee to set up a more successful system.
- Attending at least 75% of regular Regional Committee meetings in every region they serve.

Veterans Plan

The Veterans Subcommittee evaluated progress in 2017

- The CoC did not meet its goal to end Veteran homelessness in 2017, but made a lot of progress.
 - In 2017 we wrote and approved plans to end Veteran homelessness in every region.
 - More Veterans are being identified and served in the BoS.
 - Veteran referrals are part of coordinated assessment in much of the CoC. Regular SSVF participation in every Regional Committee.



The Veterans Subcommittee evaluated progress in 2017

Still in progress...

- Establish regular Veteran case conferencing in every Regional Committee.
- Establish comprehensive by-name list and dashboard for each Regional Committee in HMIS.
- Regularly evaluate CoC progress toward USICH goals.
- Submit USICH benchmark criteria.



The Veterans Subcommittee began to set goals for 2018

- The Veterans Subcommittee set a goal to end chronic and long-term Veteran homelessness by the end of 2018.
- The subcommittee plans to have more data by February, and may set additional goals then.
 - In order to have better data, all regions should have HMIS sharing agreements (QSOBAAs) in place by the end of the year.
