Dear Shana,

I am writing to reaffirm our deadline of March 9, 2018, for the Raleigh/Wake Continuum of Care (CoC) HMIS data to be included in the launch of HMIS at NCCEH. As we communicated on Feburary 7th, 2018, in order to meet our timeline for launch, NCCEH must instruct Mediware which data to move to our new system. Unfortunately, we cannot negotiate this timeline as it would put our ability to meet key deliverables in jeopardy.

However, if the Raleigh/Wake CoC does not decide to join HMIS at NCCEH by March 9th for our June launch, there will be opportunities to join in the future. Though we have not established any timeframes, we plan to welcome any additional CoCs that wish to join at a later time. We anticipate this would be handled by NCCEH issuing a notice that we are accepting applications to join our network. NCCEH and our HMIS Advisory Board would approve the addition of any CoCs. After the transition takes place in June, we will have a better understanding of the process and under what timeframe CoCs may join in the future.

We look forward to hearing your decision. Please let us know if we can provide any additional information.
