Welcome New Members & Brief Overview of Coalition

• Melissa gave a brief overview of the purpose of the Regional Committee. The purpose of the committee is to identify those individuals that are homeless and assist them in obtaining permanent, stable housing. Currently, the committee covers 10 counties.

June Steering Committee Update

- The Balance of State is planning to launch HMIS in June 2018.
- ESG Funding Priorities

- o The following types of activities are eligible under ESG funding: emergency shelter, street outreach, rapid re-housing and target prevention
- Agencies that are interested in applying for ESG funding should send the applications to the regional committee and the regional committee will send the applications to the DHHS office along with the regional application
- Regional Committees are responsible for running local competitive process of soliciting, reviewing and selecting project applications
- NCCEH staff will be providing intensive technical assistance to the ESG Funding Process Lead and their Funding Process Committee – Funding Process Lead orientation call is scheduled for June 14th from 10am – 12 noon

Coordinated Assessment Update/SSO-CE Application

- Melissa stated that agencies need to start administering the prevention and diversion tools along with VI-SPDATS. That will help to place people on the waitlist and show that there is a need in this region and hopefully bring in more money
- Trillium is the only agency administering the VI-SPDATs and Hertford County DSS is the only agency doing prevention and diversion screenings
- The quarterly report is due July 15th, but all information is due to Melissa by July 5th
- Trillium applied for the SSO-CE Grant for the region (\$20,000). If awarded, a part-time person will be hired to do Coordinated Assessment for the region. They will also take on the Lead position. If awarded the grant, the committee will be notified.

ESG Application Process

- Nicole sent out an email stating that volunteers are needed to serve on the Funding Committee and the committee needs a Funding Process Lead. The FPL will assist with the following:
 - Coordinating the annual ESG funding competition: Create a funding committee, create local priorities, attend the check-in phone calls with NCCEH Staff (new this year)
 - o Completing Regional ESG application
 - Run competitive process for selecting project applications: Create or utilize NCCEH Scorecard, utilize Decision Tree (new this year), utilize Regional and CoC Funding Priorities to select project applications.
- Members are also needed to serve on the Scorecard Committee and Project Review Committee.

• No one responded to Nicole's email. Melissa has agreed to serve on the Scorecard Committee and Lakitra will be the Funding Process Lead.

Engagement

- A discussion was had on how to engage other agencies to participate in the regional committee
- It was suggested that the committee utilize social media
- Move the meetings to other counties
