Minutes

Call to Order

• Rakendria Watford, called the meeting to order and stated that the purpose of the meeting was to introduce new partners to the committee and review the coordinated entry process.

• Those in attendance introduced themselves. The committee then reviewed the items on the agenda.

Updates

Steering Committee

- The ESG Regional Application is due to the ESG office by October 26, 2018. The committee members that are familiar with the ESG application explained it to those attending the meeting for the first time.
 - The Funding Decisions will be announced on November 26th and agencies that have been denied need to inform the ESG office by December 7th their intent to appeal. Contracts will be sent out by January 4, 2019
- **Back@Home** This program is administered by DHHS, HFA, NCCEH and 5 program agencies

- O The program is for families and individuals who are in a disaster shelter as a result of the hurricane and they have no other path out of that shelter
- o 22,000 people entered disaster shelters and about 600 are left; many individuals have no other resources to help them out of this situation
- Those individuals that qualify will be assisted with security deposits, short-term rental assistance and other similar RRH activities

• HMIS Transition

- Mediware is now called WellSky and they're continuing to work through identified global visibility issues which are contributing to a delay in the transition.
- No timeline is available for the transition until we know the full scope of the global visibility issues
- A new MOU has been signed with the NCHMIS Governance Committee to extend NCHMIS access through end of calendar year

• Point-in-Time Count

- NC BoS CoC and Data Center staff reviewed the trends in the 2018 Point-in-Time and Housing Inventory Counts, compared to recent years
- Regional Committees should elect PIT Leads by October 31st. Materials will be dispersed to PIT Leads at that time. If a region does not designate their PIT Lead, the Regional Lead will receive the materials and the responsibility to coordinate PIT tasks until a PIT Lead is identified

 - The committee would like to have every agency that is part of the committee to administer the VI-SPDAT or they can call Trillium's Call Center
 - Can a question be added to the VI-SPDAT concerning those that age out of foster care (DSS has funds that are available to help those that age out of foster care to secure housing)
 - The role of the individual hired as part of the SSO-CE grant was discussed
 - The purpose of the Regional Committee along with the different leadership roles was discussed
 - The committee discussed the difference between PSH and RRH

Regional Resource List

- The committee will work on putting a resource list together for each county within the region
 - Who to call for what services, qualifications, etc. The goal is to have this done by January 2019
 - The list will included places like DSS, Salvation Army, Housing Authorities, Food Banks, Shelters, Transportation, etc.
