1. Welcome and Introductions

Introduction of Speakers – Mike Harris, Center Director, Davidson County Facility Based Crisis Center- Daymark; Sharon Wilcox, Regional Operations Director-Daymark Recovery Services; Yesenia Mueller, MHA, Sr. Community Outreach Manager-Monarch

Mr. Harris and Ms. Wilcox provided an overview of Daymark Recovery Services Facility Based Crisis Center:

- The Davidson County facility is located at 1104 B S Main St., Lexington
- The 1 year anniversary for the current location will be next month
- FBC's are in 4 other NC Counties and a new facility is being built in Asheboro
- Last quarter 243 people were served, with 121 of them being from Davidson County
- Supports people in crisis, is community based and aids in avoiding hospitalization
- Licensed clinicians performs clinical assessments which take 1 ½ to 2 hours
- A Medical Director is on staff and there are 2 nurses round the clock
- 7 days is the typical stay, but exceptions can occur based on individual basis needs
- Referrals from the Emergency Department, law, etc.
- Individuals ages 18 to 65 with Substance Use Disorder are the predominant patients, followed by individuals with Mental Health Disorders. Individuals who have co-occurring Intellectual Developmental Disabilities and detox needs may also be served. 18 to 65
- Unable to support people who have medium or high physical health risk, have extreme violent Tendencies, or are actively suicidal
- If the FBC has to deny a person they will call mobile engagement to assist with placement
- Does not currently have IVC designation. but the process can be started in the facility
- Entrance criteria is on page 5 of the handout provided
- Typically there is little or no cost because of Medicaid and IPRS funding streams
- Entrance protocol is reviewed for staff and patient
- Therapy groups are held at 10 am and 2 pm
- Individual therapy sessions are available if needed
- AA and NA come to facility 3 days a week
- Patients meet with Aftercare Coordinator prior to discharge
- Transportation between facilities is available
- If referring a patient let them know they need to bring
 - Proof of residence,
 - Insurance or Medicaid card,
 - Medications already taking
 - Recent hospital discharge paperwork
 - Shoes, 3 shirts and pants and undergarments



• For Opioid referrals note: If the person tells you they have been using you will need to find out When they last used because of potential interactions with FBC's treatment medication

Yesenia Mueller, MHA, Sr. Community Outreach Manager – Monarch provided an overview of the Youth Crisis Center

- Serves children and adolescences
- Is one of 3 in the state and was the first to one open
- Continually evolving to best meet the needs of youth
- State Employees Credit Union Foundation made a generous donation for the program
- Started as a partnership between Cardinal and the State as an alternative for hospitalization of youth ages 6-17
- Serves youth with mental health and or substance use disabilities who may not need hospitalization
- Youth with mild to moderate IDD may also be served
- Are open 24/7
- Assessment may indicate other services/level of care are more appropriate, warranting a referral
- Length of stay runs from 3 to 7 days with 5 days being the average length of stay
- Discharge Planning is vital to ensure continuum of care upon discharge.
- Appointments have made and a crisis plan is developed and sent with them upon discharge
- Data on first 6 months of service Mecklenburg County showed good outcomes
 - 99% had no hospitalization for 30 days after discharge
 - Have served some with private insurance (cannot confirm that insurance has paid for the service, parents with private insurance opted to accept the financial risk
- Has capacity to serve additional youth
- Invited everyone to come and tour the facility
- Just received IVC designation
 - Youth must have a guardian willing to provide consent for treatment. **for voluntary admissions if guardian will not provide consent the process for IVC may be initiated to provide the youth with necessary treatment.
- Guardian provides transportation of youth to facility

 - A presentation on Suicide Prevention will be provided at DCCC
- Davidson County Community College- Single Stop Program (Matia Nelson)
 - Resource Fair on 8-13, 2018 and all are invited all to set up as vendor.
 - The two largest needs for students are housing and employment_
- Emanuel Baptist Church (Andrew Watkins)
 - The MERGE event recently took place to educate community members about mental health resources in the community.
 - Planning a program in Sept to November called Relaunch
- Davidson County Senior Services (Amanda Parris)
 - Exercise programs focusing on balance and stress release.
 - Dating event (Speed dating) men are needed
- The Arc of Davidson County (Teresa McKeon)
 - On October 5, 2018 there will be a Sensitivity training event to provide the community the Opportunity to experience the way those we support are treated. Cost is \$10.00

 - 2nd Friday of the month at 12 pm at Golden Corral.
 - Focuses is on four topics: Mental Health, Substance Use, Transportation and Provider Access This is a great Networking opportunity.
 - Medical Ministries has part time dentist
 - Adults with Medicaid 3 days a week. kids 4 days a week.
 - Provides Thomasville City schools with dental access program for youth by going into the schools
 - Dental services are available at the Lexington Clinic on Thursdays and the Thomasville clinic on Tuesdays
