#### **Governance Charter Updates**

The NC BoS CoC Governance Charter is updated annually, as required by HUD. The following has been updated to reflect changes in 2019:

- Code of Conduct
- Racial Equity Subcommittee
- Adding alternate/proxy for at-large members
- Small typos

#### Code of Conduct Policy

 NCCEH staff will set a Code of Conduct framework for all regions. Based off this framework, regions will develop a Code of Conduct to include specific needs of the region.

- The policy shall cover conflict of interest in regard to serving on funding review and selection committees and abstaining from voting when there is a conflict of interest present.
- The policy will be updated annually, and approval of the policy will be recorded in Regional Committee minutes.

#### Racial Equity Subcommittee

In response to the Racial Equity Assessment done in the NC BoS CoC, the CoC is soliciting members to participate in a Racial Equity Subcommittee to push forward next steps.

- Responsibilities of the subcommittee include:
  - Regular meetings throughout the year. The meeting schedule is determined by subcommittee members.
  - Oversees implementation of the annual Racial Equity Assessment and analyzes data collected to create a final report for the CoC Application.
  - Recommends data-informed action steps to the NC BoS CoC Steering Committee to improve equity across the CoC.
- Statement of inclusion
  - The NC BoS CoC believes that inclusion is a critical part of developing and providing best practice homeless services.
  - For this reason, the CoC believes the members of the Racial Equity Subcommittee should reflect the diversity of homeless service networks in regard to race, ethnicity, gender and gender identity, sexuality, age, education, ability, and lived experience with homelessness.
- We are hosting an open call for members with a passion for racial equity to join us!
  - o Membership on the subcommittee is open to all stakeholders in the CoC.

#### 2020 Point-in-Time/Housing Inventory Count

2020 Goal: The NC Balance of State CoC will complete an accurate and comprehensive Point-In-Time and Housing Inventory Count in 2020 throughout all of our regions.

- Number of counties reporting '0' unsheltered individuals increased from 26 in 2018 to 27 in 2019.
- Number of counties reporting '1-5' unsheltered individuals increased from 13 in 2018 to 22 in 2019.
- Things to think about when planning for an conducting an unsheltered count:
  - Start planning early
  - Engage agencies/organizations/groups in the community that might come into contact with this population
    - Law enforcement
    - Soup kitchens/food programs
    - Outreach programs: i.e. SSVF programs
    - Youth providers
  - o Build a list of known or potential locations where people living unsheltered might be
  - Advertise in the community
  - Solicit for and train volunteers

The unsheltered population is the most vulnerable that we serve because they are not accessing emergency housing of any kind and may not be accessing services at all.

PIT/HIC data is an important tool and resource for your communities

Inclusive count of homeless populations



- o Includes non-HMIS agencies
- o Includes unsheltered homeless populations
- Can use local and regional data to:
  - Understand size and scope of the homeless population
  - Assess system for gaps
    - Do your programs match the needs of your population?
  - Track increases or decreases
  - Locate and engage unsheltered homeless populations
  - Raise community and political awareness of homelessness

The PIT count provides a snapshot of the system on any given night. This year's count is on Wednesday, January 29, 2020!

#### What we are counting:

- Beds and units
  - What capacity do we have to provide emergency shelter and transitional housing?
  - What capacity do we have to provide permanent housing like rapid rehousing and permanent supportive housing?
- People
  - O How many people are experiencing homelessness?

#### **Key Terms**

- Point-in-Time Count (PIT)
  - o Count of everyone experiencing literal homelessness as defined by HUD
- Housing Inventory Count (HIC)
  - Count of the beds in the homeless service system
    - Temporary: Shelter and transitional housing
      - While here, people are counted as experiencing literal homelessness
    - Permanent: Rapid rehousing and permanent supportive housing
      - While here, people are not counted as experiencing homelessness, but we still us the surveys to inform our reports.

#### PIT Count

- Unsheltered Count: People in places not meant for human habitation
  - Outdoors
  - Tents/encampments
  - Vehicles
  - Bus or train stations
  - Abandoned buildings
- Sheltered Count: People staying in emergency shelter or transitional Housing dedicated to people experiencing homelessness

#### Counting Us App

The Counting Us App is a different app from last year, but it will have a very similar front-facing presentation to last year's app. The back end will be more streamlined so staff can collect data and report it back quicker to Regional Committees than last year.

- New/Improved from last year
- Used nationwide
- Includes expert technical support
- Includes all questions required by HUD
- Use on phones, tablets, computers
- Low-barrier access and use (does require sign-up)
- Ongoing training dates for everyone starting in November
- Available for agencies and volunteers to practice with starting in mid-November.
- App will "go live" on the night of the count
- Data submitted will be immediately able to be viewed, allowing for quicker response and reporting

The 2019 Family Reunification Program (FUP) NOFA has been released.

- For PHAs to serve:
  - Families for whom the lack of adequate housing is a primary factor in the imminent placement of a family's child in out-of-home care or the delay in the discharge of a child to the family from out-of-home care.
  - Youth between 18-24 who left foster care or will leave foster care within 90 days and are homeless or at-risk of becoming homeless.
- Applications due December 17, 2019.

The NOFA requires a MOA between PHAs, child welfare (FUP Liaison), and the CoC

- Details responsibilities to collaborate with
  - o PHA
  - o FUP Liaison: DSS, foster homes, etc.
  - o Co(
- Requires
  - o PHA to work with CoC and FUP Liaison to develop data tracking systems
  - PHA to attend CoC meetings (at least quarterly)
  - Participation in the CE process

We have gotten one MOA request from Western Piedmont Council of Government

- Vouchers
- Region 3: Catawba, Burke, Alexander, and Caldwell Counties

We anticipate more requests for MOAs prior to the December 17 deadline

Staff solicited questions or comments.

- Tambra Chamberlin leads a youth subcommittee in Region 7 and expressed questions about getting vouchers in her region for the unsheltered youth population.
  - Ehren responded that staff could see if any neighboring PHAs currently have FUP vouchers that could be used in these counties. He also suggested that there is still time to get local PHAs to apply for this year's NOFA.

A motion was made to approve any MOA requests that come in for the 2019 FUP NOFA [Martin, Smith]. All in favor, none opposed. Motion approved by unanimous consent.

#### ESG Funding Process Lead Survey

NC BoS CoC staff sent out a survey to be completed by the regional Funding Process Leads. The survey asked questions related to the technical assistance and support provided to the leads and regions for the ESG application process.

- Received results from 8 of the 13 regions
- Asked about satisfaction with the following CoC staff support:
  - o Technical Assistance: Status calls and other correspondence
  - ESG Scorecard Webinar and Q & A Session
  - Staff feedback on ESG Applications
  - Overall Impressions
- What did staff get right?
  - Staff was responsive to questions asked either during status calls, webinars, or through oneon-one contact.
  - Staff created collaboration with regional partners to make sure it all got done.
  - Staff posted materials to the website to be referred back to later.
  - Phone calls and benchmarks created by staff helped regions to stay on a tight timeline.
  - What issues and questions were raised in the survey responses?
- Scorecard
  - Some found wording and jargon confusing
  - Lack of nuance and ability to negotiate points
- Staff Review of applications
  - Long turn-around time
  - Felt like running two separate competitions
- Overall Impression



- Conflicting information from ESG and NC BoS CoC
- Lack of Steering Committee input on the review process

Staff solicited comments and discussion of the ESG process and staff technical assistance

- Melissa McKeown expressed difficulties in Region 5 for running the process in the last 3-4 years. She stated the process has been stressful due to lack of volunteers stepping up to be the lead because the workload is heavy. She also stated that a competitive process at the regional level puts strain on partnerships and relationships they need to be able to maintain throughout the year. She is concerned this process is harmful to collaboration in the region.
- Teena Willis stated she has had similar relationship strain in Regions 3 and 4.
- Kristen Martin stated that the region did not have problems with the process but that the conflicting information from the NCCEH staff and the ESG staff was difficult to maneuver.
- Jim Cox wants to know if staff has ideas for how the Steering Committee should handle the feedback from the surveys.
  - o Brian stated that staff will be meeting with the ESG office to discuss concerns. He agreed that staff also feels stuck in the middle with mandates to review applications but without all the information. He also wonders if a workgroup may need to be formed to further investigate some of these issues being raised. Does the whole process for the competition need to be reviewed?
    - Jim Cox and Monica Frizzell both stated they would like to serve on an ESG workgroup.
- Lynne James asked if other states also mandated the CoC staff review applications.
  - Brian explained that the states have autonomy to create additional rules around their funding process and are able to enforce the CoC's review applications.

A motion was made to create an ESG Workgroup [Cox, Frizzell]. All in favor, none opposed. Motion approved by unanimous consent.
