THREE	<b>Background Information:</b> In response to the Coronavirus (COVID-19), NCCEH has established an internal planning team to support the state-level response. NCCEH created a web page for homeless services providers to access COVID-19 resources from state and national partners, including the NC Department of Health and Human Services, the Centers for Disease Control, and the US Department of Housing and Urban Development. NCCEH held calls for shelter and permanent housing providers to think through strategies in addressing COVID-19. NCCEH staff will provide updates on the North Carolina COVID-19 response and seek updates from the field.
