


Racial Equity Subcommittee Meeting NC Balance of State CoC






#### Camera

To foster connection, we encourage every member to **turn on** their camera. Graphic is at the bottom of your screen.


We have a lot of people! It may be easier to set the cameras to only show who is currently speaking. You can access this setting at the top of the screen.





## Dialogue Series

1st Dialogue: will center a panel of Black professionals discussing personal experiences and reactions to police violence, systemic racism, and how these impact the homeless services system, and the professionals who work in it. There will be time for discussion and input for attendees. White professionals are encouraged to attend and to listen, but the intent of this dialogue is to center the voices of our Black colleagues in Balance of State.

2nd Dialogue: will be a discussion on the term White Supremacy, it's meaning and impact and connection with the work of ending systemic racism. A panel discussion format will also be utilized and include White professionals discussing the role of White people in combating white supremacy. There will be time for input from participants and White people and People of Color are all encouraged to attend and participate.

Does the applicant have an Anti-discrimination Policy?



# **CoC Scorecard Racial Equity Questions**

Does the applicant hold annual trainings on its Anti-Discrimination Policy, as required by the CoC Anti-Discrimination Policy?

Has the agency sent staff to an external training for Racial Equity or Anti-Discrimination in the last 12 months?

Does the applicant have an equal access hiring clause in job postings?

What percentage of your Board of Directors is non-white?
