



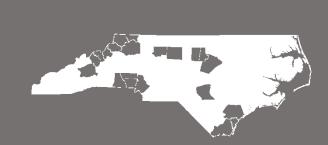

COVID-19 Pandemic Response



ESG-CV-1 RFA released with tight turnaround for applications.

NC DHHS released the RFA along with application materials and supporting documents on Monday, June 22nd.

Three allocations of Funding

1) ESG-CV First Allocation

- This RFA, funds must be spent by Sept 30,2022
- 2) ESG-CV Second Allocation
 - Future RFA(s), funds must be spent by Sept 30, 2022

3) FY2021 Funds

Annual allocation, future RFA, funds for Jan-Dec 2021





Decision Point: Allocation of Funding

NC DHHS requires that CoCs implement a 60/40 funding split.

- Minimum 60% for Housing Stabilization
- Maximum 40% for Crisis Response and HMIS

Submitted Crisis Response Project Applications total 40% of total allocation to the CoC

 3 regions (Regions 2, 7, 12) have Crisis Response applications > 40% of fair share

Two viable options:

- 1) Stay with 60/40 split at the CoC level (no justification letter required)
- 2) Stay with 60/40 split at LPA level (requires Regions 2, 7, 12 to submit a justification letter)



NC BoS CoC has an HMIS budget shortfall.

Additional funds are necessary to continue providing HMIS at no cost to agencies for licenses and support.

- State has indicated that money may be available from another state resource to fill the gap.
- If this does not materialize, NCCEH may ask for an allocation from NC BoS CoC ESG-CV funds

Back@Home Letters of Support

- Agencies have submitted requests for letters of support from NC BoS CoC to accompany project applications for providing prevention and rapid rehousing services with ESG-CV funding through Back@Home.
 - Current requests would provide coverage in all 79 counties of NC BoS CoC.
 - 19 agencies have applied for letters of support covering 1 to 42 counties.
 - With these letters, the CoC will support the <u>agency</u> to apply for these funds, not their application. NC DHHS will review and select Back@Home rehousing agencies.

Updated Coordinated Entry Written Standards language

"During a state of emergency, the North Carolina Balance of State Continuum of Care (NC BoS CoC) will be permitted to quickly change Coordinated Entry (CE) access, prioritization, and referral policies and procedures to respond to emerging needs and funding. Local CE leads may make changes to their regional systems without approval from the Coordinated Entry Council (CEC) but will be required to report changes to the CEC at the next scheduled meeting. The Coordinated Entry Council will approve changes without needing the Steering Committee approval and will be required to publicly post any approved changes. Any changes to CE policies and procedures made during a state of emergency will only be effective until the state of emergency is rescinded unless the CEC proposes permanent changes to the Steering Committee and the Steering Committee approves said changes."

Racial Equity Subcommittee Update

The subcommittee successfully recommended additions to the CoC scorecard committee to ensure that funding process includes a racial equity component. The goal is to find ways to reward agencies for incorporating racial equity into their everyday processes.

The annual Racial Equity Assessment work has begun. NCCEH's Data Center is doing an initial data pull in preparation to meet with the Racial Equity Assessment Workgroup on July 17.



- Specific requests for data go to the Data Center (hmis@ncceh.org)





People Counted in PIT, 2010-2020






2020 Point-in-Time Count

PIT LIVING SITUATION 2020



People Experiencing Unsheltered Homelessness





Total People Counted by Region 2020




PIT Across NC Balance of State CoC: Sub-populations


Total Experiencing Chronic Homelessness by Region 2020
