 - o 10.8 mil in grants with the BoS
 - BoS CoC submitted application early

 - Things to work on within CoC
 - Income employment and unearned income
 - Looking for partnerships/agreements with work agencies, temp agencies, any workforce programs/agencies that will make our application stronger. Unearned income, i.e., SOAR – we want to increase unearned income advantages across our region.

VII. Coordinated Entry Update - Bonnie

- Everyone that is doing HMIS should be doing all VI-SPDAT's on HMIS. If you are not, you need to email them to Bonnie and she will put them in HMIS.
- When VI-SPDAT done and qualify for housing program, send Bonnie the client HMIS number and VI-SPDAT score. She will put them on the by name list for the PSH and RRH programs.
- Only one list for RRH and PSH.
- If you house someone then you need to notify Bonnie so the date they were housed can be documented.
- Bonnie is the ONLY ONE who can access list.
- Prevention and Diversion Bonnie is the only one who can do Prevention and Diversion there was discussion and Bonnie will be clarifying this.
- Bonnie said that the current housing list needs to be UPDATED and each agency needs to review
 the list to update their clients. Bonnie will send out the list that needs to be updated from the
 current google docs list.
- AN EMAIL NEEDS TO GO OUT TO WHOLE GROUP ABOUT UPDATING THE LIST. NO LONGER USING GOOGLE DOCS. EVERYTHING FILTERS THROUGH BONNIE! THE PRIORITY LIST ON GOOGLE DOCS WILL BE REMOVED TO PREVENT CONFUSION BY ADDING PEOPLE TO THE LIST.
- NCCEH wants case conferencing every two weeks, not once a month.
 - Start doing Case Conferencing the first and third Wednesdays of the month. On first Wednesday, at 9:30 a.m. and on the third Wednesday, after our Uni5 meeting.

VII. Agency Updates and other Discussions

- Karen Jacobs (from Vessels of Mercy in Morganton) under the umbrella of CCRP (establish in 2012 for men) and Vessels of Mercy is the ladies component of CCRP, established in 2016.
 - o Ministry for ladies with substance issues, year-long transition program. Very intense, Christian program. 8 "comfortable" beds with room for 2 more.
 - Referrals for Vessels come from Grace Home or Bethel Colony. Wait period can be 1-3 months.
- Teena Community Support Team definition is out for comment, a new service definition that is a "team approach" that has tenancy supports included.
- WPCOG applied for mainstream vouchers again this year, covering 4 of our counties (Burke, Catawba, Alexander and Caldwell) and they were able to change their preference without closing the waitlist or exhaust it to meet the preferences within the mainstream voucher definition.
