




Housing Stabilization Status






Moved-In Households by Rehousing Agency






Stabilized in Place Households by Rehousing Agency







Enrollment Status Detail




HQS Inspections

- Socialserve is auditing past inspections to ensure completeness
 - If not, they will contact to rectify
 - In future, will do ongoing monitoring for completeness



Lead Based Paint Inspection

- Required for household with children under 6 AND unit built before 1978
 - Question added to smartsheet form re children





Lead Based Paint Inspection

- If yes to child question, will trigger Socialserve to document year built
- If unit built before 1978, inspection for LBP will be required
 - If unit fails, it will undergo additional testing
 - If unit fails additional testing, it cannot be used



Smartsheet Tips

Client Duplicates

- We had a one-time re-organization of date for oversight reporting
 - Accidentally triggered the automation to resend referrals
- We've removed those duplicates but let us know if you see more
 - Thanks for helping to identify this issue!



Sort + Filters

- Sort a column to find rows faster
 - New entries come in at bottom of sheet, can resort in alpha order
- Filters can be used on your Client List to show particular rows
- Similar to filters in excel, except more advanced
